4 **ORDINANCE 2026-140**

5 AN ORDINANCE REGARDING CHAPTER 745 (ADDRESSING  
6 AND STREET NAMING REGULATIONS), *ORDINANCE CODE*;  
7 RENAMING CONFEDERATE STREET EXTENDING BETWEEN  
8 HUBBARD STREET AND LIBERTY STREET TO "ROSE ARBOR  
9 WAY" IN COUNCIL DISTRICT 7 PURSUANT TO SECTION  
10 745.105 (PUBLIC STREET NAME CHANGES), *ORDINANCE*  
11 *CODE*; DIRECTING THE LEGISLATIVE SERVICES  
12 DIVISION TO FORWARD A COPY OF THIS ORDINANCE,  
13 ONCE ENACTED, TO THE PUBLIC WORKS DEPARTMENT,  
14 DEVELOPMENT SERVICES DIVISION, ADDRESSING  
15 SECTION, FOR PROCESSING, IMPLEMENTATION, AND  
16 COORDINATION WITH VARIOUS CITY DEPARTMENTS AND  
17 OTHER AFFECTED AGENCIES AND ORGANIZATIONS;  
18 PROVIDING AN EFFECTIVE DATE.

20 **WHEREAS**, the Jacksonville City Council desires to rename  
21 Confederate Street between Hubbard Street and Liberty Street in  
22 Council District 7 to "Rose Arbor Way"; and

23 **WHEREAS**, the Springfield Preservation and Revitalization  
24 Council, Inc. recommended renaming Confederate Street to "Rose Arbor  
25 Way" to commemorate the historic rose arbor located in Springfield  
26 Park and a copy of said recommendation is attached hereto as **Exhibit**  
27 **1** and incorporated hereby by this reference; and

28 **WHEREAS**, the street name change from "Confederate Street" to  
29 "Rose Arbor Way" affects the address assignment of one property owner,  
30 the City of Jacksonville, and a Small Cell Equipment locator; and

31 **WHEREAS**, pursuant to subsection 745.105(j)(10), *Ordinance Code*,

1 the Public Works Department, Development Services Division,  
2 Addressing Section, mailed written notifications to the affected  
3 property owners on December 16, 2025, requesting the affected property  
4 owners to indicate their written consent or objection to the proposed  
5 street renaming and copies of said written notifications are attached  
6 hereto as **Exhibit 2** and **Exhibit 3**, respectively, and incorporated  
7 herein by this reference; and

8 **WHEREAS**, one affected property owner, the City of Jacksonville,  
9 consented to the proposed street renaming and a copy of said consent  
10 form is attached as **Exhibit 4** and incorporated herein by this  
11 reference; and

12 **WHEREAS**, pursuant to subsection 745.105(j)(10), *Ordinance Code*,  
13 the remaining affected property owner is deemed to have consented to  
14 the proposed street renaming due to its non-response to the written  
15 notification; and

16 **WHEREAS**, the Historic Preservation Section of the Community  
17 Planning Division of the Planning and Development Department issued  
18 a Memorandum to the Jacksonville Historic Preservation Commission  
19 ("JHPC") indicating it did not have an objection to the renaming of  
20 "Confederate Street" to "Rose Arbor Way" and a copy of said Memorandum  
21 is attached hereto as **Exhibit 5** and incorporated herein by this  
22 reference; and

23 **WHEREAS**, on September 24, 2025, the JHPC held a public meeting  
24 where it considered this matter and voted to recommend approval of  
25 the renaming of "Confederate Street" to "Rose Arbor Way" and a copy  
26 of an excerpt of the transcript of said meeting is attached hereto  
27 as **Exhibit 6** and incorporated hereby by this reference; and

28 **WHEREAS**, the Public Works Department, Development Services  
29 Division, reviewed the proposed renaming for presentation to the 911  
30 Emergency Addressing Advisory Committee and confirmed that City  
31 Addressing staff had no objections to the renaming of "Confederate

1 Street" to "Rose Arbor Way" and a copy of said presentation is  
2 attached hereto as **Exhibit 7** and incorporated herein by this  
3 reference; and

4 **WHEREAS**, on November 5, 2025, the 911 Emergency Addressing  
5 Advisory Committee considered the request during a public meeting and  
6 voted to approve the renaming of Confederate Street between Hubbard  
7 Street and Liberty Street in Council District 7 to "Rose Arbor Way"  
8 and a copy of the Summary of Meeting Minutes of said meeting is  
9 attached hereto as **Exhibit 8** and incorporated herein by this  
10 reference; and

11 **WHEREAS**, the applicant completed the required application and  
12 paid the required fee for the street renaming and a copy of the  
13 application and the payment receipt are attached hereto as **Exhibit 9**  
14 and **Exhibit 10**, respectively, and incorporated herein by this  
15 reference; and

16 **WHEREAS**, upon this legislation becoming effective, the City will  
17 install a new street sign at the affected roadway segment to reflect  
18 "Rose Arbor Way" as the designated street name; now therefore

19 **BE IT ORDAINED** by the Council of the City of Jacksonville:

20 **Section 1. Confederate Street renamed as "Rose Arbor Way".**  
21 Confederate Street extending between Hubbard Street and Liberty  
22 Street in Council District 7 is hereby renamed as "Rose Arbor Way"  
23 by which name such street and physical location shall be hereafter  
24 known and designated. A copy of the map of Rose Arbor Way is attached  
25 hereto as **Exhibit 11** and incorporated herein by this reference.

26 **Section 2. Directing the Legislative Services Division to**  
27 **forward a copy to the Public Works Department.** The Legislative  
28 Services Division is hereby directed to send a copy of this Ordinance,  
29 once enacted, to the Public Works Department, Development Services  
30 Division, Addressing Section, for processing, implementation, and  
31 coordination with 911 Emergency, the Jacksonville Fire and Rescue

1 Department, the U.S. Post Office, and other affected agencies and  
2 organizations pertaining to the road renaming approved herein.

3 **Section 3. Effective Date.** This Ordinance shall become  
4 effective upon signature by the Mayor or upon becoming effective  
5 without the Mayor's signature.
