(c) Explanation of Appropriation

2 The funding above represents an appropriation of \$200,000.00, including \$100,000.00 in grant funding 3 awarded by the National Fish and Wildlife Foundation 4 5 ("NFWF"), and \$100,000.00 from the City Resiliency Infrastructure Improvements Project for the City match, 6 7 for the NFWF Green Infrastructure Project ("Project") to provide funding for the Project. The grant period commenced 8 9 on January 1, 2025 and continues through December 31, 2027. 10 A local match of \$100,000.00 is required.

Section 2. Purpose. The purpose of the appropriation in 11 Section 1 is to provide funding for the Project which is intended to 12 create a framework for prioritizing green infrastructure projects on 13 public lands to increase resilience and create wildlife habitat. The 14 Project will develop a prioritized list of green infrastructure 15 projects to progress toward implementation in the next five years to 16 17 reduce heat stress, reduce flooding, improve water quality, and enhance wildlife habitats. The Project will help identify the most 18 19 effective types of green infrastructure projects for specific 20 locations where flooding mitigation is needed to ensure continued 21 access to and provision of valuable services. The Project will 22 facilitate the implementation of green infrastructure projects across 23 the City of Jacksonville, which will benefit community resilience by 24 reducing flooding. The completion of the Project will also make Jacksonville competitive for grant funding to construct green 25 26 infrastructure projects. A copy of the National Fish and Wildlife Foundation Grant Agreement providing the terms and conditions 27 28 applicable to the grant awarded for the Project has been placed **On** File with the Legislative Services Division. 29

30 Section 3. Capital Improvement Plan Amendment. Ordinance
 31 2024-505-E, adopting the 2025-2029 Five-Year Capital Improvement Plan

## Amended 6/24/25

(the "CIP") for the City and certain of its independent agencies, is 1 2 hereby amended to provide funding for the Project, as more fully 3 described in the Project Information Sheet, attached hereto as Revised Exhibit 2, labeled as "Revised Exhibit 2, Rev CIP Sheet, June 16, 4 5 2025 - NCSPHS" and incorporated herein by this reference. The Council finds that the deferral of this amendment of the CIP until the next 6 7 annual budget and CIP review will be detrimental to the best interests of the community because such deferral will result in unnecessary 8 9 delay of the Project and loss of grant funding for the Project.

Pursuant to Section 122.605(c), Ordinance Code, enactment of this Ordinance requires the affirmative vote of two-thirds of the Council members present at the meeting because of the CIP amendment set forth in this section. This Ordinance shall constitute an amendment to Ordinance 2024-505-E. In all other respects, the Five-Year Capital Improvement Plan approved by Ordinance 2024-505-E shall remain unchanged and continue in full force and effect.

Section 4. Oversight. The Planning and Development
Department, Office of Resiliency, shall oversee the Project and
administration of the grant described herein.

20 Section 5. Effective Date. This Ordinance shall become 21 effective upon signature by the Mayor or upon becoming effective 22 without the Mayor's signature.
