

## **BUSINESS IMPACT ESTIMATE**

OF ALPHA KAPPA ALPHA SORORITY), FROM DESIGNATED CONTINGENCY ACCOUNTS WITHIN THE GENERAL FUND TO THE PRIVATE ORGANIZATIONS ACCOUNT WITHIN THE KIDS HOPE ALLIANCE ("KHA") FUND TO PROVIDE FUNDING FOR VARIOUS YOUTH PROGRAMS AND SERVICES (THE "PROGRAMS") AS DESCRIBED HEREIN; AMENDING THE FOURTH REVISED SCHEDULE M TO ORDINANCE 2023-511-E; INVOKING THE EXEMPTION IN SECTION 126.107(G) (EXEMPTIONS), PART 1 (GENERAL REGULATIONS), CHAPTER 126 (PROCUREMENT CODE), ORDINANCE CODE, TO ALLOW FOR DIRECT CONTRACTS WITH SIGMA BETA CLUB OF JACKSONVILLE INC., DELTA SIGMA THETA SORORITY, INC., JACKSONVILLE ALUMNAE CHAPTER, KAPPA ALPHA PSI JACKSONVILLE FOUNDATION, INCORPORATED, BETA ALPHA ZETA CHAPTER OF ZETA PHI BETA SORORITY, INC., OMEGAS 4 CHANGE, INC. (AFFILIATE OF OMEGA PSI PHI THETA PHI CHAPTER, INC.), AND ALPHA-JAX FOUNDATION, INC. (GAMMA RHO OMEGA CHAPTER, INC. OF ALPHA KAPPA ALPHA SORORITY) FOR THE PROGRAMS; WAIVING THE REQUIREMENTS OF SECTION 77.111(A) (PROVIDER CONTRACTS), CHAPTER 77 (KIDS HOPE ALLIANCE), ORDINANCE CODE, TO EXEMPT THE SERVICES TO BE PROVIDED BY THE AFOREMENTIONED ORGANIZATIONS FROM COMPETITIVE PROCUREMENT; APPROVING, AND AUTHORIZING THE MAYOR, OR HER DESIGNEE, AND CORPORATION SECRETARY, AND/OR THE CHIEF EXECUTIVE OFFICER OF KHA TO EXECUTE AND DELIVER, AN AGREEMENT BETWEEN THE CITY AND SIGMA BETA CLUB OF JACKSONVILLE INC., DELTA SIGMA THETA SORORITY, INC., JACKSONVILLE ALUMNAE CHAPTER, KAPPA ALPHA PSI JACKSONVILLE FOUNDATION, INCORPORATED, BETA ALPHA ZETA CHAPTER OF ZETA PHI BETA SORORITY, INC., OMEGAS 4 CHANGE, INC. (AFFILIATE OF OMEGA PSI PHI THETA PHI CHAPTER, INC.), AND ALPHA-JAX FOUNDATION, INC. (GAMMA RHO OMEGA CHAPTER, INC. OF ALPHA KAPPA ALPHA SORORITY) FOR THE PROGRAMS; PROVIDING FOR OVERSIGHT BY KHA; PROVIDING AN EFFECTIVE DATE.
