ORDINANCE 2023-793

AN ORDINANCE NAMING THE CITY-OWNED BUILDING LOCATED AT 6360 COMMERCE STREET, JACKSONVILLE, FLORIDA 32211, IN COUNCIL DISTRICT 1, PURSUANT TO SECTION 122.105 (PUBLIC BUILDINGS, PUBLIC FACILITIES AND PUBLIC PARKS NAMING AND RENAMING PROCEDURES), ORDINANCE CODE, TO BE KNOWN AS THE "RITA F. REAGAN BUILDING"; PROVIDING AN EFFECTIVE DATE.

The original set building located in the Norman Studios Complex at 6360 Commerce Street will be named the "Rita F. Reagan Building" pursuant to the process outlined in Section 122.105, Ordinance Code. This renaming acknowledges the contributions Ms. Reagan made to the Jacksonville community and specifically the Norman Studios Complex and Museum.
