

## FLOOR AMENDMENT

Council Member Bowman offers the following Floor Amendment to File No. 2023-377:

- (1) On **page 1, line 5, and page 3, lines 15 and 17, strike** "\$2,845,370.37" and **insert** "\$2,845,370.37";
- (2) On **page 1, line 7, strike** "THE HODGES & GLEN KERNAN BOULEVARD" and **insert** "THE "HODGES BLVD & GLEN KERNAN BLVD";
- (3) On **page 1, line 19, after "SAME;" insert** "AMENDING THE 2023-2027 FIVE-YEAR CAPITAL IMPROVEMENT PLAN APPROVED BY ORDINANCE 2022-505-E TO REFLECT THIS APPROPRIATION OF FUNDS;";
- (4) On **page 3, line 12, strike** "Exhibit 1" and **insert** "Revised Exhibit 1, labeled as "Revised Exhibit 1, Rev B.T., June 13, 2023 - Floor"";
- (5) On **page 3, lines 15 and 17, strike** "B.T. 23 -" and **insert** "Revised Exhibit 1";
- (6) On **page 3, line 19, strike** "existing" and **insert** "12 existing Capital Improvement Plan";
- (7) On **page 3, line 27, strike** "Intersection" and **insert** "intersection";
- (8) On **page 4, line 1, strike** "Exhibit 2" and **insert** "Revised Exhibit 2, labeled as "Revised Exhibit 2, Rev Agmt, June 13, 2023 - Floor"";
- (9) On **page 4, line 21½, insert** and a new Section 4 to read as follows:

**"Section 4. Capital Improvement Plan Amendment.**  
Ordinance 2022-505-E, adopting the 2023-2027 Five-Year

Capital Improvement Plan (the "CIP") for the City and certain of its independent agencies, is hereby amended to reflect this reallocation of funds from 12 CIP projects to the Hodges Blvd & Glen Kernan Blvd Improvements project as more fully described in the Project Information Sheets attached hereto as **Exhibit 3** and incorporated herein by this reference. The City Council finds that the deferral of this amendment of the CIP until the next annual budget and CIP review will be detrimental to the best interests of the community because such deferral will delay the urgent need to alleviate traffic congestion and promote safety at the intersection.

Pursuant to Section 122.605(c), *Ordinance Code*, enactment of this Ordinance requires the affirmative vote of two-thirds of the City Council members present at the meeting because of the CIP amendment set forth in this section. This Ordinance shall constitute an amendment to Ordinance 2022-505-E. In all other respects, the Five-Year Capital Improvement Plan approved by Ordinance 2022-505-E shall remain unchanged and continue in full force and effect.";

- (10) Renumber remaining Sections accordingly;
- (11) Remove **Exhibit 1** and replace with **Revised Exhibit 1**, attached hereto, which attaches the revised B.T. to reflect correct account information, include a missing page, and remove an unnecessary page;

- (12) Remove **Exhibit 2** and replace with **Revised Exhibit 2**, attached hereto, which attaches the revised Agreement to reflect the total construction budget, incorporate the payment and performance bond requirements, and correct scrivener's errors;
- (13) Attach **Exhibit 3**, attached hereto, which attaches the CIP Project Information Sheets for all projects;
- (14) On **page 1, line 1**, amend the introductory sentence to add that the bill was amended as reflected herein.
