ORDINANCE 2025-645-E

AN ORDINANCE APPROPRIATING \$31,227 FROM THE SPECIAL COUNCIL CONTINGENCY ACCOUNT TO THE COUNCIL FOR FITNESS AND WELL-BEING - OTHER PROFESSIONAL SERVICES ACCOUNT, TO PROVIDE FUNDING TO SUPPORT THE ACTIVITIES AND INITIATIVES OF THE MAYOR'S COUNCIL ON FITNESS AND WELL-BEING (THE "COUNCIL"); PROVIDING FOR CARRYOVER; PROVIDING AN EFFECTIVE DATE.

BE IT ORDAINED by the Council of the City of Jacksonville:

Section 1. Appropriation. For the 2024-2025 fiscal year, within the City's budget, there is hereby appropriated the indicated sum(s) from the account(s) listed in subsection (a) to the account(s) listed in subsection (b):

(c) Explanation of Appropriation:

The funding above represents an appropriation of \$31,227 from the Special Council Contingency account to the Council for Fitness and Well-Being - Other Professional Services account, to provide funding to support the activities and

1 initiatives of the Mayor's Council on Fitness and Well-
2 Being including, but not limited to, development of a
3 strategic plan and public awareness campaign for community
4 wellness.

5 **Section 2. Purpose.** The purpose of the appropriation in
6 Section 1 is to provide funds for the Mayor's Council on Fitness and
7 Well-Being (the "Council") to support the activities and initiatives
8 of the Council in Fiscal Year 2025-2026. The Council was created in
9 1987 by Executive Order of Mayor Thomas L. ("Tommy") Hazouri as an
10 official agency of the City tasked to evaluate, coordinate, initiate
11 and promote fitness and well-being opportunities, facilities and
12 awareness in the City of Jacksonville.

13 **Section 3. Carryover.** The funds appropriated herein shall
14 not lapse but shall carryover to fiscal year 2025-2026.

15 **Section 4. Effective Date.** This Ordinance shall become
16 effective upon signature by the Mayor or upon becoming effective
17 without the Mayor's signature.
