## FINANCE AMENDMENT

The Finance Committee offers the following amendment to File No. 2025-191:

- (1) On page 1, line 16, after "REQUIREMENTS)," <u>insert</u> "AMENDING SECTION 118.808 (FUNDING ALLOCATIONS BY THE PSG COUNCIL; GRANT AWARD LIMITATIONS)";
- (2) On page 1, line 29, after "REQUIREMENTS," <u>insert</u> "REDUCE THE MAXIMUM GRANT AWARD AMOUNT TO \$125,000 WITHIN EACH CATEGORY OF MOST VULNERABLE PERSONS AND NEEDS, PROVIDE THAT REQUESTING AGENCIES SHALL BE ELIGIBLE TO RECEIVE ONLY ONE PUBLIC SERVICE GRANT PER FISCAL YEAR,";
- (3) On page 2, line 30, after "Requirements)," <u>insert</u> "118.808 (Funding Allocations by the PSG Council; Grant Award Limitations)";
- (4) On page 3, line 6, after "Requirements)," <u>insert</u> "118.808 (Funding Allocations by the PSG Council; Grant Award Limitations)";
- (5) On page 8, line 15<sup>1</sup>/<sub>2</sub>, <u>insert</u> new language to read as follows:
  "Sec. 118.808 Funding Allocations by the PSG Council; Grant Award Limitations.
  - (a) Limitations on Grant Awards. Individual grants within each category of Most Vulnerable Persons and Needs shall be based on the high score model for funding purposes. The high score model shall award 100 percent of requested funding for the highest ranked score up to the maximum amount of \$125,000\$150,000. The next highest ranked score shall be awarded 100 percent of the requested

funding up to <u>\$125,000</u> subsets and so on until the funds are exhausted. Requesting agencies may submit one application per category of Most Vulnerable Persons and Needs pursuant to subsection 118.805(b)(5)(vii) but shall be eligible to receive only one Public Service Grant per fiscal year so long as the application meets the eligibility, application, minimum score and all other applicable requirements for award of a Public Service Grant pursuant to this Part. In the event multiple applications from a single requesting agency meet the aforementioned requirements and receive a sufficient score to receive a Public Service Grant, the requesting agency shall select which program receives the award.
