6 A RESOLUTION SUPPORTING HOUSE BILL 0385
7 DESIGNATING A PORTION OF U.S. ROUTE 301
8 BETWEEN U.S. ROUTE 90 AND SUMMER FIELD LANE IN
9 DUVAL COUNTY AS "TROOPER EDWIN J. GASQUE
10 MEMORIAL HIGHWAY"; DIRECTING THE CHIEF OF
11 LEGISLATIVE SERVICES TO SEND A COPY OF THIS
12 RESOLUTION TO THE FLORIDA DEPARTMENT OF
13 TRANSPORTATION, DUVAL LEGISLATIVE DELEGATION,
14 THE FLORIDA SENATE PRESIDENT AND THE SPEAKER
15 OF THE FLORIDA HOUSE; PROVIDING AN EFFECTIVE
16 DATE.

18 **WHEREAS**, during the 2019 Legislative Session, the Florida
19 Legislature passed House Bill 0385, which makes honorary
20 designations of transportation facilities through Florida and
21 directs the Florida Department of Transportation (FDOT) to erect
22 suitable markers for those designations; and

23 **WHEREAS**, House Bill 0385 designates that portion of U.S. Route
24 301 (72140000) between U.S. Route 90 and Summer Field Lane in Duval
25 County as "Trooper Edwin J. Gasque Memorial Highway" in Duval
26 County; and

27 **WHEREAS**, Section 334.071, *Florida Statutes*, provides that a
28 city or county must pass a resolution in support of a particular
29 designation before road markers are erected; and

30 **WHEREAS**, the City of Jacksonville wishes to honor Trooper
31 Edwin J. Gasque and requests that the Florida Department of

1 Transportation erect suitable markers designating a portion of U.S.
2 Route 301 (72140000) between U.S. Route 90 and Summer Field Lane in
3 Duval County as "Trooper Edwin J. Gasque Memorial Highway"; now
4 therefore

5 **BE IT RESOLVED** by the Council of the City of Jacksonville:

6 **Section 1.** The City of Jacksonville strongly supports
7 House Bill 0385, and designation of a portion of U.S. Route 301
8 (72140000) between U.S. Route 90 and Summer Field Lane in Duval
9 County as "Trooper Edwin J. Gasque Memorial Highway", and hereby
10 authorizes the erection of appropriate signage by the Florida
11 Department of Transportation to commemorate the designation.

12 **Section 2. Direction to Chief of Legislative Services.**
13 The Chief of Legislative Services for the City Council is hereby
14 directed to provide a copy of this Resolution to the Florida
15 Department of Transportation, Duval County Legislative Delegation,
16 Florida Senate President and Speaker of the Florida House.

17 **Section 3. Effective Date.** This Resolution shall become
18 effective upon signature by the Mayor or upon becoming effective
19 without the Mayor's signature.
