6 AN ORDINANCE CONCERNING THE CREATION OF AN
7 ADMINISTRATOR POSITION TO SUPPORT THE WORK OF
8 THE DUVAL COUNTY TOURIST DEVELOPMENT COUNCIL
9 ("TDC") AND ITS EXECUTIVE DIRECTOR;
10 APPROPRIATING \$13,823.00 FROM TOURIST
11 DEVELOPMENT COUNCIL FUND BALANCE TO PROVIDE
12 FUNDING FOR SUCH POSITION; PURPOSE OF
13 APPROPRIATION; APPROVING THE POSITION, AS
14 INITIATED BY R.C. 22-164; REQUESTING ONE CYCLE
15 EMERGENCY PASSAGE; PROVIDING FOR AN EFFECTIVE
16 DATE.

19 **WHEREAS**, the TDC has identified a need to create and hire the
20 job position of administrator to support the work of the TDC and its
21 executive director as authorized under Section 70.103(d), *Ordinance*
22 *Code*; and

23 **WHEREAS**, at its meeting on June 30, 2022, the TDC approved the
24 creation of this position; now therefore,

25 **BE IT ORDAINED** by the Council of the City of Jacksonville:

26 **Section 1. Appropriation.** For the 2021-2022 fiscal year,
27 within the City's budget, there is hereby appropriated the indicated
28 sum from the account listed in subsection (a) to the account listed
29 in subsection (b):

5 (c) Explanation of Appropriation.

6 This ordinance appropriates \$13,823 from Tourist
7 Development Council fund balance to the TDC Administration
8 activity to provide funding for the salaries, benefits,
9 and office expenses of the administrator position through
10 September 30, 2022.

11 **Section 2. Purpose.** The purpose of the appropriation in
12 Section 1 is to provide funding for the creation of the job position
13 of administrator in order to provide administrative and office support
14 to the TDC and its executive director.

15 **Section 3. Approval of Position.** There is hereby
16 approved the position more fully described in R.C. 22-164, attached
17 hereto as **Exhibit 2** and incorporated herein by this reference.

18 **Section 4. Requesting emergency one cycle passage pursuant**
19 **to Council Rule 4.901 Emergency.** One cycle emergency passage of this
20 legislation is requested. The nature of the emergency is that the
21 appropriation is needed in order to fill the administrator position
22 as soon as possible.

23 **Section 5. Effective Date.** This Ordinance shall become
24 effective upon signature by the Mayor or upon becoming effective
25 without the Mayor's signature.
