5 AN ORDINANCE CONFIRMING THE MAYOR'S  
6 REAPPOINTMENT OF RUSSELL JACKSON, A DUVAL COUNTY  
7 RESIDENT, AS A CITIZEN MEMBER OF THE KINGSOUTEL  
8 CROSSING COMMUNITY REDEVELOPMENT AGENCY  
9 ADVISORY BOARD THAT LIVES WITHIN ONE MILE OF THE  
10 CRA BOUNDARY REPRESENTING THE GENERAL PUBLIC,  
11 PURSUANT TO SECTION 53.202 (MEMBERSHIP;  
12 APPOINTMENT AND REMOVAL; TERMS OF OFFICE), PART  
13 2 (KINGSOUTEL CROSSING COMMUNITY REDEVELOPMENT  
14 AGENCY ADVISORY BOARD), CHAPTER 53 (COMMUNITY  
15 REDEVELOPMENT AGENCY ADVISORY BOARDS),  
16 *ORDINANCE CODE*, FOR A SECOND FULL TERM TO EXPIRE  
17 ON DECEMBER 31, 2026; WAIVING SECTION 53.202  
18 (MEMBERSHIP; APPOINTMENT AND REMOVAL; TERMS OF  
19 OFFICE), PART 2 (KINGSOUTEL CROSSING COMMUNITY  
20 REDEVELOPMENT AGENCY ADVISORY BOARD), CHAPTER 53  
21 (COMMUNITY REDEVELOPMENT AGENCY ADVISORY  
22 BOARDS) TO ALLOW THE APPOINTMENT OF A CITIZEN  
23 WHO DOES NOT PRESENTLY LIVE WITHIN ONE MILE OF  
24 THE CRA BOUNDARY; PROVIDING AN EFFECTIVE DATE.

26 **WHEREAS**, Ordinance 2019-446-A appointed Russell Jackson to the  
27 KingSoutel Crossing Community Redevelopment Agency Advisory Board as  
28 a citizen member that lives within one mile of the CRA Boundary  
29 representing the general public;

30 **WHEREAS**, at present he does not live within one mile of the CRA  
31 Boundary; now therefore

1  
2 **BE IT ORDAINED** by the Council of the City of Jacksonville:

3 **Section 1. Reappointment.** The Council hereby confirms the  
4 Mayor's reappointment of Russell Jackson, a Duval County resident,  
5 to the KingSoutel Crossing Community Redevelopment Agency Advisory  
6 Board, as a citizen member that lives within one mile of the CRA  
7 boundary representing the general public, pursuant to section 53.202  
8 (Membership; appointment and removal; terms of office), Part 2  
9 (KingSoutel Crossing Community Redevelopment Agency Advisory Board),  
10 Chapter 53 (Community Redevelopment Agency Advisory Boards),  
11 *Ordinance Code*, for a second full term to expire on December 31,  
12 2026.

13 **Section 2. Waiving Section 53.202 (Membership; appointment**  
14 **and removal; terms of office), Part 2 (KingSoutel Crossing Community**  
15 **Redevelopment Agency Advisory Board), Chapter 53 (Community**  
16 **Redevelopment Agency Advisory Boards), *Ordinance Code*.** The  
17 provisions of Section 53.202 (Membership; appointment and removal;  
18 terms of office), Part 2 (KingSoutel Crossing Community Redevelopment  
19 Agency Advisory Board), Chapter 53 (Community Redevelopment Agency  
20 Advisory Boards), *Ordinance Code*, are hereby waived to allow for Mr.  
21 Jackson's appointment even though he does not at present live within  
22 one mile of the CRA boundary. The City finds that Mr. Jackson has  
23 held his current seat since July 23, 2019 and acquired significant  
24 experience within the Northside community which would be beneficial  
25 to the Advisory Board and City.

26 **Section 3. Effective Date.** This ordinance shall become  
27 effective upon signature by the Mayor or upon becoming effective  
28 without the Mayor's signature.
