ORDINANCE 2026-582

AN ORDINANCE CONFIRMING THE APPOINTMENT OF COUNCIL MEMBER TYRONA CLARK-MURRAY TO THE FLORIDA LEAGUE OF CITIES, REPLACING COUNCIL MEMBER TERRANCE FREEMAN, FOR A TERM CONCURRENT WITH THE REMAINDER OF HER FIRST FULL TERM OF OFFICE; WAIVING COUNCIL RULE 1.306(A)(2) (DESIGNATED LEAGUE OF CITIES AND ASSOCIATION OF COUNTIES COUNCIL MEMBER APPOINTMENTS), *COUNCIL RULES*, AS TO THE REQUIREMENT THAT ONE COUNCIL MEMBER SHALL BE A SECOND TERM COUNCIL MEMBER; PROVIDING AN EFFECTIVE DATE.

WHEREAS, in order to fully participate and benefit from membership in the League of Cities, Ordinance 2017-97-E authorized two Council Members to attend the League of Cities meetings; and

WHEREAS, Council Rule 1.306(a)(2) provides that the City Council President shall appoint a first term Council Member and a second term Council Member to serve as the Council's designated members of the League of Cities; and

WHEREAS, presently, Council Member Kevin Carrico serves as the first-term Council Member designated by the Council to serve on the Florida League of Cities; and

WHEREAS, Council Member Tyrona Clark-Murray was elected to represent Council District 9 in the special general election on August 23, 2022, and served a partial term, and on May 16, 2023, Council Member Clark-Murray was elected to represent Council District 9 for a first full term ending June 30, 2027; and

1 **WHEREAS**, although Council Member Tyrona Clark-Murray is in her
2 first full term, Council President Howland has appointed her to serve
3 as one of the designated members to the League of Cities, filling the
4 seat designated for a second-term Council Member; now therefore

5 **BE IT RESOLVED** by the Council of the City of Jacksonville:

6 **Section 1. Confirmation of Appointment.** The Council hereby
7 confirms the Council President's appointment of Council Member Tyrona
8 Clark-Murray to the League of Cities, replacing Council Member
9 Terrance Freeman, for a term concurrent with the remainder of her
10 first full term of office.

11 **Section 2. Waiver of Council Rule 1.306(a)(2) (Designated**
12 **League of Cities and Association of Counties Council Member**
13 **Appointments), Council Rules.** Council Rule 1.306(a)(2) (Designated
14 League of Cities and Association of Counties Council Member
15 Appointments), Part 3 (Members of Council), Chapter 1 (Organization
16 of the Council), is hereby waived as to the requirement that one
17 Council Member appointed to the League of Cities shall be a second
18 term Council Member. A waiver of Council Rule 1.306(a)(2) is needed
19 because both Council Members designated as members of the League of
20 Cities are serving their first full terms.

21 **Section 3. Effective Date.** This Ordinance shall become
22 effective upon signature by the Mayor or upon becoming effective
23 without the Mayor's signature.
