AN ORDINANCE APPROVING THE PROPOSED 2024B SERIES TEXT AMENDMENT TO THE FUTURE LAND USE ELEMENT OF THE 2045 COMPREHENSIVE PLAN OF THE CITY OF JACKSONVILLE TO AMEND THE OPERATIVE PROVISIONS AND THE LOW DENSITY RESIDENTIAL (LDR) AND MEDIUM DENSITY RESIDENTIAL (MDR) CATEGORIES RELATING TO DUPLEXES, TRI-PLEXES AND QUAD-PLEXES AND DENSITY IN THE MISSING MIDDLE AND ADOPTING THE MISSING MIDDLE OVERLAY MAP, FOR TRANSMITTAL TO THE STATE OF FLORIDA'S VARIOUS AGENCIES FOR REVIEW; WAIVING THE REQUIREMENTS OF SECTION 650.405 (PLANNING COMMISSION ADVISORY RECOMMENDATION AND PUBLIC HEARING), PART 4 (AMENDMENTS TO THE COMPREHENSIVE PLAN), CHAPTER 650 (COMPREHENSIVE PLANNING FOR FUTURE DEVELOPMENT), ORDINANCE CODE, THAT THE PLANNING COMMISSION HOLD A PUBLIC HEARING AND MAKE A RECOMMENDATION TO THE CITY COUNCIL REGARDING THIS LEGISLATION PRIOR TO THE COUNCIL COMMITTEE OF REFERENCE REPORTING ITS RECOMMENDATION TO THE CITY COUNCIL; PROVIDING A DISCLAIMER THAT THE AMENDMENT TRANSMITTED HEREIN SHALL NOT BE CONSTRUED AS AN EXEMPTION FROM ANY OTHER APPLICABLE LAWS; PROVIDING AN EFFECTIVE DATE.

WHEREAS, the Planning and Development Department has initiated

certain revisions and modifications to the text of the 2045 Comprehensive Plan in accordance with the procedures and requirements set forth in Chapter 650, Part 4, Ordinance Code, to amend the Operative Provisions and the Low Density Residential (LDR) and Medium Density Residential (MDR) portions of the Future Land Use Element and to adopt the Missing Middle Overlay Map into the Future Land Use Element, which are more particularly set forth in Exhibit 1, attached hereto, dated October 30, 2024, and incorporated herein by reference; and

WHEREAS, for the purposes of this legislation and pursuant to Section 163.3174, Florida Statutes, the City Council hereby designates the City Council Land Use and Zoning (LUZ) Committee as the Local Planning Agency for the City of Jacksonville to review and make a recommendation regarding the proposed 2024B Series Text Amendment to the Future Land Use Element of the 2045 Comprehensive Plan described herein; and

WHEREAS, the LUZ Committee, acting as the Local Planning Agency as designated herein, held a public hearing on this proposed Amendment pursuant to Chapter 650, Part 4, Ordinance Code, and Chapter 163, Florida Statutes, with due public notice having been provided, and having considered all written and oral comments received during the public hearing, has made its recommendation to the Council; and

WHEREAS, the City Council held a public hearing on this proposed Amendment with public notice having been provided, pursuant to Section 163.3184(3), Florida Statutes, and Chapter 650, Part 4, Ordinance Code, and having considered all written and oral comments received during the public hearing, the recommendations of the Planning and Development Department, the Planning Commission and the LUZ Committee, desires to transmit this proposed Amendment through the State's expedited state review process to the Florida Department of Commerce, as the State Land Planning Agency, the Northeast Florida

Regional Council, the Florida Department of Transportation, the St. Johns River Water Management District, the Florida Department of Environmental Protection, the Florida Fish and Wildlife Conservation Commission, the Department of State's Bureau of Historic Preservation, the Florida Department of Education, and the Department of Agriculture and Consumer Affairs; now therefore

BE IT ORDAINED by the Council for the City of Jacksonville:

Section 1. Approval of Amendment for Transmittal Purposes.

The Council hereby approves the proposed 2024B Series Text Amendment to the Future Land Use Element of the 2045 Comprehensive Plan, as set forth in **Exhibit 1**, attached hereto, dated October 30, 2024, for transmittal to Florida's various required State Agencies for review.

Section 2. Waiver of Section 650.405, Ordinance Code. The requirements of Section 650.405 (Planning Commission advisory recommendation and public hearing), Part 4 (Amendments to the Comprehensive Plan), Chapter 650 (Comprehensive Planning For Future Development), Ordinance Code, that the Planning Commission hold a public hearing and make a recommendation to the City Council on amendments to the Comprehensive Plan prior to the Council committee of reference reporting its recommendation to the City Council are hereby waived as the Council hereby designates the Land Use and Zoning Committee to act as the City's Local Planning Agency for the purposes of this legislation. Therefore, this matter is hereby discharged from further consideration by the Planning Commission.

Section 3. Disclaimer. The transmittal approved herein shall <u>not</u> be construed as an exemption from any other applicable local, state, or federal laws, regulations, requirements, permits or approvals. All other applicable local, state or federal permits or approvals shall be obtained before commencement of the development or use, and transmittal is based upon acknowledgement, representation and confirmation made by the applicant(s), owner(s), developer(s)

and/or any authorized agent(s) or designee(s) that the subject business, development and/or use will be operated in strict compliance with all laws. Transmittal does **not** approve, promote or condone any practice or act that is prohibited or restricted by any federal, state or local laws.

Section 4. Effective Date. This Ordinance shall become effective upon the signature by the Mayor or upon becoming effective without the Mayor's signature.
