7 AN ORDINANCE APPROPRIATING \$494,313.40 FROM
8 RETAINED EARNINGS IN SUBFUND 561 (SELF
9 INSURANCE) IN ORDER TO RESTORE TAX INCREMENT
10 DOLLARS TO THE NORTHBANK CRA RESULTING FROM AN
11 OVERPAYMENT OF THE BUDGETED AMOUNT FOR THE
12 SELF INSURANCE FUND LOAN REPAYMENT, AS
13 INITIATED BY B.T. 20-044; PROVIDING AN
14 EFFECTIVE DATE.

16 **BE IT ORDAINED** by the Council of the City of Jacksonville:

17 **Section 1. Appropriation.** For the 2019-2020 fiscal year,
18 within the City's budget, there are hereby appropriated the
19 indicated sum(s) from the account(s) listed in subsection (a) to
20 the account(s) listed in subsection (b):

27 (c) **Explanation of Appropriation**

28 The appropriation above is a transfer from retained
29 earnings in subfund 561 (Self Insurance) to the Northbank
30 Downtown CRA Trust to restore tax increment dollars from

1 an overpayment of the budgeted amount for the self
2 insurance fund loan repayment.

3 **Section 2. Purpose.** The purpose of the appropriation in
4 Section 1 is to restore tax increment dollars to the Northbank CRA
5 resulting from an overpayment of the budgeted amount for the self
6 insurance fund loan repayment. The overpayment was made because of
7 a change in the loan amortization schedule. A revised amortization
8 schedule is attached hereto as **Exhibit 2**, which replaces the
9 amortization schedule previously approved by 2017-504-E.

10 **Section 3. Effective Date.** This ordinance shall become
11 effective upon signature by the Mayor or upon becoming effective
12 without the Mayor's signature.
