**RESOLUTION 2025-670**

A RESOLUTION CONFIRMING THE COUNCIL PRESIDENT'S REAPPOINTMENT OF ALEX MOYE, A ST. JOHNS COUNTY RESIDENT, TO THE PUBLIC NUISANCE ABATEMENT BOARD, AS A COMMUNITY ADVOCATE, PURSUANT TO CHAPTER 672 (PUBLIC NUISANCE ABATEMENT BOARD), *ORDINANCE CODE*, FOR A SECOND FULL TERM ENDING SEPTEMBER 30, 2028; ESTABLISHING A SUBSTANTIAL ECONOMIC BUSINESS INTEREST IN DUVAL COUNTY, PURSUANT TO SECTION 50.102 (MEMBERS OF BOARDS AND COMMISSIONS), PART 1 (ORGANIZATION), CHAPTER 50 (ORGANIZATION OF BOARDS AND COMMISSIONS), *ORDINANCE CODE*; PROVIDING AN EFFECTIVE DATE.

**BE IT RESOLVED** by the Council of the City of Jacksonville:

**Section 1. Reappointment.** The Council hereby confirms the Council President's reappointment of Alex Moye, a St. Johns County resident, to the Public Nuisance Abatement Board, as a community advocate, pursuant to Chapter 672, *Ordinance Code*, for a second full term ending September 30, 2028.

**Section 2. Establishing a Substantial Economic Business Interest in Duval County.** Section 50.102 (Members of boards and commissions), Part 1 (Organization), Chapter 50 (Organization of Boards and Commissions), *Ordinance Code*, requires board and commission members appointed pursuant to Chapter 50 and confirmed by Council to be either permanent residents of Duval County or to maintain a substantial economic business or philanthropic interest as determined by the City Council within Duval County. In this

1 instance, although the appointee does not reside within Duval County,  
2 Mr. Moye is Partner and Senior Engineer at the civil engineering firm  
3 of Waitz & Moye, Inc., owned and operated by the Moye family and  
4 located on Southside Boulevard in Jacksonville.

5 **Section 3. Effective Date.** This Resolution shall become  
6 effective upon signature by the Mayor or upon becoming effective  
7 without the Mayor's signature.
