10 THE 2021 REDISTRICTING AMENDMENTS SET FORTH IN
11 ORDINANCE 2022-0001-E AND THE REAPPORTIONMENT OF
12 THE FLORIDA HOUSE OF REPRESENTATIVES, FLORIDA
13 SENATE, AND UNITED STATES CONGRESSIONAL LINES
14 APPROVED BY THE FLORIDA LEGISLATURE, AS
15 REQUESTED BY THE SUPERVISOR OF ELECTIONS
16 PURSUANT TO SECTION 352.101, *ORDINANCE CODE*;
17 PROVIDING FOR PRECINCT MAPS ON FILE AND ONLINE;
18 PROVIDING AN EFFECTIVE DATE.

20 **BE IT ORDAINED** by the Council of the City of Jacksonville:

21 **Section 1. Precincts Boundaries Changes Approved;**
22 **Authorizing and Directing Supervisor of Elections and Council**
23 **Secretary to Include Boundary Changes On File in Their Respective**
24 **Offices.** At the request of the Supervisor of Elections for Duval
25 County, as a result of the redistricting of the Council districts in
26 Ordinance 2022-0001-E and reapportionment of the Florida House of
27 Representatives, Florida Senate, and United States Congressional
28 lines approved by the Florida Legislature, and pursuant to Section
29 352.101, *Ordinance Code*, the Council, acting as the governing body
30 for Duval County, hereby approves the precinct boundary changes and
31 renumbering of precincts in the City of Jacksonville, Duval County,

1 Florida, as reflected in the individual Council District maps attached
2 hereto as **Exhibit 1**. The Supervisor of Elections and the Council
3 Secretary are hereby authorized and directed to include the boundary
4 changes on file in their respective offices.

5 **Section 2. Precinct Boundary Change and Polling Place Maps**
6 **on File at Supervisor of Elections and Council Secretary Offices.** A
7 precinct boundary map of the entire county, a map of each new
8 precinct, and the locations of all precinct polling places are On
9 File in the offices of the Supervisor of Elections and the Council
10 Secretary. A written description of each precinct boundary is on
11 file in the offices of the Supervisor of Elections.
