4 **ORDINANCE 2020-403**

5 AN ORDINANCE APPROVING, AND AUTHORIZING THE
6 MAYOR, OR HIS DESIGNEE, AND CORPORATION
7 SECRETARY TO EXECUTE AND DELIVER, A
8 COOPERATIVE AGREEMENT BETWEEN THE CITY OF
9 JACKSONVILLE AND COLUMBIA COUNTY FOR MEDICAL
10 EXAMINER SERVICES AND REIMBURSEMENT; PROVIDING
11 FOR OVERSIGHT BY THE MEDICAL EXAMINER'S
12 OFFICE; PROVIDING AN EFFECTIVE DATE.

14 **WHEREAS**, pursuant to Chapter 406, Florida Statutes, the
15 District IV Medical Examiner provides services to two counties in
16 District III, Columbia County and Hamilton County; and

17 **WHEREAS**, the District IV Medical Examiner is to be compensated
18 for his or her services by the two District III counties; and

19 **WHEREAS**, Duval County has allocated the annual salary to be
20 paid the District IV Medical Examiner for the full services
21 rendered to the two District III counties; and

22 **WHEREAS**, Columbia County should reimburse Duval County for the
23 value of the District IV Medical Examiner's services it receives;
24 and

25 **WHEREAS**, Columbia County and Duval County desire to enter into
26 a Cooperative Agreement for Medical Examiner Services under which
27 Columbia County is to reimburse Duval County for the value of the
28 District IV Medical Examiner's services it receives; now, therefore

29 **BE IT ORDAINED** by the Council of the City of Jacksonville:

30 **Section 1. Approval and authorization to execute and**
31 **deliver Cooperative Agreement and other documents.** There is hereby

1 approved, and the Mayor, or his designee, and Corporation Secretary
2 are hereby authorized to execute and deliver, a Cooperative
3 Agreement between the City of Jacksonville and Columbia County for
4 Medical Examiner Services and Reimbursement, in substantially the
5 same form as is attached hereto as **Exhibit 1** and incorporated
6 herein by this reference, and all other documents necessary or
7 appropriate to effectuate the purpose of this ordinance.
8 Reimbursement from Columbia County for services provided to
9 Columbia County by the District IV Medical Examiner shall be as set
10 forth in Ordinance 2017-370-E, and the term of the agreement shall
11 be for a period of three (3) years commencing October 1, 2020, and
12 ending September 30, 2023. The Medical Examiner will review the
13 fees annually no later than June of each year and should it be
14 determined by the Medical Examiner that fees do not sufficiently
15 cover the City's financial exposure, a notice of increase will be
16 given to Columbia County with an effective date of October 1, 2021
17 and/or 2022, thus providing a ninety (90) day notice of any
18 increase in fees.

19 **Section 2. Oversight.** The Medical Examiner's Office
20 shall oversee the project described herein.

21 **Section 3. Effective Date.** This ordinance shall
22 become effective upon signature by the Mayor or upon becoming
23 effective without the Mayor's signature.
