ORDINANCE 2025-739-E

AN ORDINANCE APPROPRIATING \$3,000.00 FROM THE CONTRIBUTIONS FROM PRIVATE SOURCES ACCOUNT TO THE OTHER PROFESSIONAL SERVICES ACCOUNT WITHIN THE ART IN PUBLIC PLACES TRUST FUND TO PROVIDE FUNDING FOR THE MAINTENANCE OF ARTWORK LOCATED IN LANDON PARK, AS INITIATED BY REVISED B.T. 25-123; PROVIDING FOR OVERSIGHT BY THE CULTURAL COUNCIL OF GREATER JACKSONVILLE, INC.; PROVIDING AN EFFECTIVE DATE.

BE IT ORDAINED by the Council of the City of Jacksonville:

Section 1. Appropriation. For the 2025-2026 fiscal year, within the City's budget, there are hereby appropriated the indicated sum(s) from the account(s) listed in subsection (a) to the account(s) listed in subsection (b):

(c) Explanation of Appropriation - Appropriating funding in the amount of \$3,000.00 from the Contributions From Private Sources account to the Other Professional Services account

1 within the Art in Public Places Trust Fund for maintenance
2 costs associated with the artwork entitled "Transform"
3 located in Landon Park (the "Public Art"). The funds
4 appropriated herein shall be disbursed at the request of
5 the Cultural Council of Greater Jacksonville, Inc.

6 **Section 2. Purpose.** The purpose of the appropriation in
7 Section 1 above is to allocate the \$3,000.00 in funds received in
8 connection with the donation of the Public Art which is now an insured
9 asset of the City to provide funding to the Art in Public Places
10 Trust Fund for maintenance of the Public Art, including preventative
11 preservation measures such as washing and waxing or more substantial
12 repairs.

13 **Section 3. Oversight.** The Cultural Council of Greater
14 Jacksonville, Inc. shall be responsible for the maintenance of the
15 Public Art.

16 **Section 4. Effective Date.** This Ordinance shall become
17 effective upon signature by the Mayor or upon becoming effective
18 without the Mayor's signature.
