22 WHEREAS, an application for a zoning exception, On File with 23 the City Council Legislative Services Division, was filed by Lawrence 24 Yancy, on behalf of the owner of property located in Council District 25 8 at 10663 Monaco Drive between Dunn Avenue and Beckner Avenue (R.E. 26 No(s). 044148-0055) (the "Subject Property"), requesting an 27 establishment or facility which includes the retail sale and service of all alcoholic beverages including liquor, beer or wine for on-28 29 premises consumption, for Centy Way, LLC (DBA) Centy Way, in the Commercial Community/General-1 (CCG-1) District; and 30

WHEREAS, the Planning and Development Department

has

1 considered the application and all attachments thereto and has 2 rendered an advisory recommendation; and

WHEREAS, the Land Use and Zoning Committee, after due notice, held a public hearing and having duly considered both the testimonial and documentary evidence presented at the public hearing, has made its recommendation to the Council; now therefore

7 BE IT ORDAINED by the Council of the City of Jacksonville: Section 1. Adoption of Findings and Conclusions. 8 The 9 Council has considered the recommendation of the Land Use and Zoning 10 Committee and reviewed the Staff Report of the Planning and Development Department concerning application for zoning exception 11 E-24-40. Based upon the competent, substantial evidence contained in 12 the record, the Council hereby determines that the requested zoning 13 exception meets each of the following criteria required to grant the 14 request pursuant to Section 656.131(c), Ordinance Code, 15 as specifically identified in the Staff Report of the Planning and 16 17 Development Department:

(1) Will be consistent with the Comprehensive Plan, includingany subsequent plan adopted by the Council pursuant thereto;

(2) Will be compatible with the existing contiguous uses or zoning and compatible with the general character of the area, considering population density, design, scale and orientation of structures to the area, property values, and existing similar uses or zoning;

(3) Will not have an environmental impact inconsistent with thehealth, safety and welfare of the community;

(4) Will not have a detrimental effect on vehicular or pedestrian traffic, or parking conditions, and will not result in the generation or creation of traffic inconsistent with the health, safety and welfare of the community;

(5) Will not have a detrimental effect on the future development

1 of contiguous properties or the general area, according to the 2 Comprehensive Plan, including any subsequent amendment to the plan 3 adopted by the Council;

4 (6) Will not result in the creation of objectionable or
5 excessive noise, lights, vibrations, fumes, odors, dust or physical
6 activities, taking into account existing uses or zoning in the
7 vicinity;

(7) Will not overburden existing public services and facilities;

9 (8) Will be sufficiently accessible to permit entry onto the 10 property by fire, police, rescue and other services; and

(9) Will be consistent with the definition of a zoning exception, and will meet the standards and criteria of the zoning classification in which such use is proposed to be located, and all other requirements for such particular use set forth elsewhere in the Zoning Code, or otherwise adopted by the Planning Commission or Council.

17 Therefore, zoning exception application E-24-40 is hereby18 approved.

Section 2. Owner and Description. The Subject Property is owned by 10663 Monaco Dr, LLC, and is described in Exhibit 1, dated November 22, 2023, and graphically depicted in Exhibit 2, both attached hereto. 24 Section 3. Failure to exercise the zoning 3 exception, if herein granted, by the commencement of the use or action 4 herein approved within one (1) year of the effective date of this 5 legislation shall render this zoning exception invalid and all rights 6 arising therefrom shall terminate.
