8 **ORDINANCE 2020-249-E**

9 AN ORDINANCE APPROPRIATING \$75,000 FROM
10 AUTHORIZED CAPITAL PROJECTS/INVESTMENT POOL
11 EARNINGS TO PROVIDE FUNDING FOR THE CREATION
12 AND INSTALLATION OF A FALLEN FIREFIGHTER
13 MEMORIAL AT FIRE STATION ONE ("PROJECT");
14 PROVIDING A CARRYOVER OF FUNDS FROM YEAR TO
15 YEAR UNTIL SUCH FUNDS ARE EXPENDED OR LAPSE
16 ACCORDING TO THE AGREEMENT; APPROVING AND
17 AUTHORIZING THE MAYOR OR HIS DESIGNEE AND
18 CORPORATION SECRETARY TO EXECUTE AND DELIVER
19 AN AGREEMENT ("AGREEMENT") WITH BRODIN
20 STUDIOS, INC. TO CREATE AND INSTALL THE
21 MEMORIAL IN ACCORDANCE WITH THE AGREEMENT;
22 REQUESTING THAT THE JACKSONVILLE FIRE AND
23 RESCUE DEPARTMENT OVERSEE THE AGREEMENT AND
24 PROJECT; REQUESTING ONE CYCLE EMERGENCY
25 PASSAGE; PROVIDING AN EFFECTIVE DATE.

27 **BE IT ORDAINED** by the Council of the City of Jacksonville:

28 **Section 1. Appropriation.** For the 2019-2020 fiscal year,
29 within the City's budget there are hereby appropriated the
30 indicated sum(s) from the account(s) listed in subsection (a) to

1 the account(s) listed in subsection (b):

3 incorporated herein)

8 (c) Explanation of Appropriation

9 The appropriation transfers \$75,000 from Authorized
10 Capital Projects/Investment Pool Earnings for the
11 installation of a fallen firefighter memorial at Fire
12 Station 1.

13 **Section 2. Purpose.** The purpose of the appropriation in
14 Section 1 is to pay for the installation of a fallen firefighter
15 memorial at Fire Station 1.

16 **Section 3. Carryover.** The funds appropriated herein shall
17 not lapse but shall carryover as appropriated from year to year
18 until such funds are expended or lapse according to the terms of
19 the Agreement.

20 **Section 4. Approving and Authorizing an agreement with**
21 **Brodin Studios, Inc. for the installation of the Memorial.** There
22 is hereby approved, and the Mayor and Corporation Secretary are
23 authorized to enter into an agreement ("Agreement") between the
24 City and Brodin Studios, Inc. ("Company"). Pursuant to the
25 Agreement, the Company will create and install the Memorial at Fire
26 Station 1, as further detailed in the Agreement ("Project"). The
27 Jacksonville Fire and Rescue Department shall obtain an
28 administrative award for the City to enter into the Agreement
29 pursuant to Section 126.107(a), *Ordinance Code*.

1 **Section 5. Oversight Department.** The Jacksonville Fire
2 and Rescue Department shall provide oversight for the Agreement and
3 Project.

4 **Section 6. Requesting one cycle emergency passage**
5 **pursuant to Council Rule 4.901 Emergency.** One cycle emergency
6 passage of this legislation is requested. The nature of the
7 emergency is that October 4, 2020, is National Fallen Firefighters
8 Memorial Weekend and the Fallen Firefighters Memorial project needs
9 to be completed prior to that date.

10 **Section 7. Effective Date.** This Ordinance shall become
11 effective upon signature by the Mayor or upon becoming effective
12 without the Mayor's signature.
