A RESOLUTION AUTHORIZING THE GRANTING OF A NON-SOLID RESIDENTIAL WASTE COLLECTION AND TRANSPORTATION FRANCHISE TO FIVE TALENT SERVICES, LLC D/B/A MOBILEDUMPS OF JACKSONVILLE PURSUANT CHAPTER TO380 (SOLID MANAGEMENT), PART 6 (NONRESIDENTIAL SOLID WASTE AND TRANSPORTATION FRANCHISES), ORDINANCE CODE; PROVIDING FOR OVERSIGHT BY THE DEPARTMENT OF PUBLIC WORKS, SOLID DIVISION; PROVIDING AN EFFECTIVE DATE.

Franchise Agreement Authorized. In accordance Section 1. with the provisions of Chapter 380 (Solid Waste Management), Part 6 (Nonresidential Solid Collection Waste and Transportation Franchises), Ordinance Code, the Director of the Public Works Department is hereby authorized to issue a franchise agreement to Five Talent Services, LLC d/b/a Mobiledumps of Jacksonville for collection and transportation of non-residential solid waste in the City of Jacksonville. Five Talent has paid the application fee of \$1,500.00. A copy of the Non-Residential Solid Waste Collection and Transportation Franchise Agreement is attached hereto as Exhibit 1 and incorporated herein by this reference. A copy of the letter from the Department of Public Works forwarding Five Talent's application to the Council for action is attached hereto as Exhibit 2 and incorporated herein by this reference.

Section 2. Oversight. The Solid Waste Division of the Department of Public Works shall oversee the franchise described herein.

Section 3. Effective Date. This Resolution shall become effective upon signature by the Mayor or upon becoming effective without the Mayor's signature.
