JACKSONVILLE HOUSING AND COMMUNITY DEVELOPMENT COMMISSION MEETING MINUTES

Call Meeting to Order, Welcome and Introductions

Chair David Wakefield called the meeting to order at 9:30 a.m.

Approval of Minutes

A motion to approve the minutes from February 28, 2024, meeting was made by Commissioner Sol Wynter and seconded by Commissioner David Hacker. **MOTION PASSED: 6-0**

II. Chief's Report

Chief Jeffrey informed the Commission of current progress of various Housing and Community Development Division (HCDD) programs. Programs are on target with no major issues at this time. He provided an update regarding the Mayor's roofing program. City Council approved the additional funding of \$500,000 for a total of \$900,000 to be administered through the program. The roofing program will re-open for additional applicants to apply, a date has not been determined. Chief Jeffrey provided details regarding the Preservation & Reinvestment Initiative for Community Enhancement (PRICE) grant. We are in the process of completing the application and will be requesting \$22,000,000.00. The Price Grant supports communities in their efforts to maintain, protect, and stabilize manufactured housing and manufactured housing communities (MHCs). The PRICE main funding will support low- and moderate-income homeowners with manufactured housing units and manufactured housing communities with critical investments such as repairs, infrastructure improvements, and upgrades to increase resilience.

III. Presentation of Proposed 2024-2025 Funding – Erich Chatham

Erich Chatham provided handout and discussed the proposed funding for the Community Development Block Grant (CDBG), Emergency Solutions Grant (ESG), Housing Opportunities for Persons with Aids (HOPWA), HOME Investment Partnership Program, and State Housing Initiative Partnership (SHIP). For a detailed funding list please reference the handout 2024-2025 Proposed UA Awards, attached to and made of these minutes.

IV. Approval of the Proposed 2024-2025 Funding

A motion to approve the proposed 2024-2025 funding, subject to final determination of Federal and State grant awards, was made by Commissioner Sol Wynter and seconded by Commissioner Earl Matthews.
