## ORDINANCE 2025-425

AN ORDINANCE AUTHORIZING THE GRANTING OF A NON-SOLID RESIDENTIAL WASTE COLLECTION AND TRANSPORTATION FRANCHISE TO CAPITAL WASTE SERVICES LLC D/B/A CWS - JAX HAULING PURSUANT TO CHAPTER 380 (SOLID WASTE MANAGEMENT), PART 6 WASTE (NONRESIDENTIAL SOLID COLLECTION AND TRANSPORTATION FRANCHISES), ORDINANCE PROVIDING FOR OVERSIGHT BY THE OFFICE ADMINISTRATIVE SERVICES, SOLID WASTE DIVISION; PROVIDING AN EFFECTIVE DATE.

WHEREAS, Capital Waste Services LLC d/b/a CWS - Jax Hauling ("Capital Waste") has submitted an application for a non-residential solid waste collection and transportation franchise pursuant to the provisions of Chapter 380, Part 6, Ordinance Code; and

WHEREAS, the application was reviewed by the Solid Waste Division of the Office of Administrative Services; and

WHEREAS, the Office of Administrative Services recommends granting a franchise for non-residential solid waste collection and transportation to Capital Waste; and

WHEREAS, granting a non-residential solid waste collection and transportation franchise to Capital Waste is in the best interest of the City and will further the purpose for which the franchise program was adopted, including, but not limited to, safeguarding public health, safety and welfare in the collection and transportation of solid waste through Jacksonville; now therefore

BE IT ORDAINED by the Council of the City of Jacksonville:

Franchise Agreement Authorized. In accordance Section 1. with the provisions of Chapter 380 (Solid Waste Management), Part 6 (Nonresidential Solid Waste Collection and Transportation Franchises), Ordinance Code, the Manager of the Office of Administrative Services is hereby authorized to issue a franchise agreement to Capital Waste Services LLC d/b/a CWS - Jax Hauling for collection and transportation of non-residential solid waste in the City of Jacksonville. Capital Waste has paid the application fee of \$1,500.00. A copy of the Non-Residential Solid Waste Collection and Transportation Franchise Agreement is attached hereto as Exhibit 1 and incorporated herein by this reference. A copy of the letter from the Office of Administrative Services forwarding Capital Waste's application to the Council for action is attached hereto as Exhibit 2 and incorporated herein by this reference.

Section 2. Oversight. The Solid Waste Division of the Office of Administrative Services shall oversee the franchise described herein.

Section 3. Effective Date. This Resolution shall become effective upon signature by the Mayor or upon becoming effective without the Mayor's signature.
