5 A RESOLUTION CONFIRMING THE MAYOR'S APPOINTMENT
6 OF EMILY PIERCE, AS A LAY MEMBER OF THE MOBILITY
7 SYSTEM WORKING GROUP, PURSUANT TO SECTION
8 655.509 (MOBILITY SYSTEM WORKING GROUP), PART 5
9 (MOBILITY SYSTEM), CHAPTER 655 (CONCURRENCY AND
10 MOBILITY MANAGEMENT SYSTEM), *ORDINANCE CODE*, TO
11 SERVE FOR A TERM ENDING WHEN THE CITY COUNCIL
12 TAKES FINAL ACTION ON THE RECOMMENDATIONS OF THE
13 MOBILITY SYSTEM WORKING GROUP; PROVIDING AN
14 EFFECTIVE DATE.

16 **WHEREAS**, Section 655.509, *Ordinance Code*, requires the
17 Planning and Development Department to evaluate the Mobility System
18 and Chapter 655 (Concurrency and Mobility Management System) of the
19 Ordinance Code with respect to the Mobility System, within two years
20 following the adoption of the North Florida Transportation Planning
21 Organization's Long Range Transportation Plan ("LRTP"), but at least
22 once every ten years regardless of receipt of the LRTP, and shall
23 update the Mobility System as provided in Section 655.504, *Ordinance*
24 *Code*; and

25 **WHEREAS**, the Planning and Development Department shall conduct
26 an analysis and present recommendations of appropriate amendments to
27 the Mobility System and Chapter 655 to the Mobility System Working
28 Group, which shall be convened for the purpose of reviewing and
29 approving such recommendations; and

30 **WHEREAS**, the Mobility System Working Group shall be comprised
31 of seven members, with one City Council member appointed by the City

1 Council President, two lay citizens appointed by the City Council
2 President, three lay members appointed by the Mayor, and one lay
3 member appointed jointly by the Mayor and the City Council President;
4 and

5 **WHEREAS,** the Planning and Development Department shall provide
6 the Mayor and the Council with recommendations approved by the
7 Mobility System Working Group (the "Recommendations") for action by
8 the legislative and executive branches of government within 90 days
9 after the approval; and

10 **WHEREAS,** all members of the Mobility System Working Group shall
11 serve until the City Council takes final action on the
12 Recommendations; now therefore

13 **BE IT RESOLVED** by the Council of the City of Jacksonville:

14 **Section 1. Appointment Confirmation.** The Council hereby
15 confirms the Mayor's appointment of Emily Pierce, as a lay member of
16 the Mobility System Working Group, in accordance with Section 655.509
17 (Mobility System Working Group), Part 5 (Mobility System), Chapter
18 655 (Concurrency and Mobility Management System), *Ordinance Code*, to
19 serve for a term ending when the City Council takes final action on
20 the Recommendations.

21 **Section 2. Effective Date.** This Resolution shall become
22 effective upon signature by the Mayor or upon becoming effective
23 without the Mayor's signature.
