BE IT ORDAINED by the Council of the City of Jacksonville:

24 Section 1. Lease Agreement Approved and Execution 25 Authorized. There is hereby approved, and the Mayor, or her designee, 26 and the Corporation Secretary are hereby authorized to execute and 27 deliver that certain Lease between Blue Cross and Blue Shield of Florida, Inc. and the City of Jacksonville in substantially the same 28 29 form as has been placed **On File** with the Office of Legislative 30 Services. Said Lease is for the property located at 532 Riverside Avenue, Jacksonville, Florida 32202 (the "Property"), inclusive of 31

any existing improvements, structures, and facilities located thereon 1 2 as more particularly described in the Lease, for a one hundred and forty-nine (149) month initial term with two (2) five-year (5) 3 renewals, commencing on the effective date of the Lease. The Lease 4 authorizes the use of 58,959 square feet of the premises for general 5 office space at a rate of \$20.00 per square foot annually, and an 6 7 additional 3,567 square feet for garage space at \$6.00 per square foot, all rates subject to a three percent (3%) annual rate increase. 8 9 Upon completion of tenant improvements, gross rent shall be abated 10 for ten (10) months and may be converted to additional tenant improvement dollars. 11

12Section 2.OversightDepartment.TheJacksonville13Sheriff's Office shall oversee administration of the Lease described14herein.

15 Section 3. Effective Date. This Ordinance shall become 16 effective upon signature by the Mayor or upon becoming effective 17 without the Mayor's signature.
