ΑN ORDINANCE APPROVING THE ISLE OF PATMS DEPENDENT SPECIAL DISTRICT AMENDED FISCAL YEAR 2019/2020 BUDGET, PER ORDINANCE 2011-724-E AND SECTION 189.02, FLORIDA STATUTES; PROVIDING AN EFFECTIVE DATE.

WHEREAS, the City of Jacksonville established the Isle of Palms Dependent Special District (the "District"), per Ordinance 2011-724-E and section 189.02, Florida Statutes, a dependent special district for the purpose of dredging the Isle of Palms canal system; and

WHEREAS, in order for the District to qualify as a dependent special district per section 189.02, Florida Statutes, the City, in Ordinance 2011-724-E, required the District to submit its proposed budget to the City Council every year by April 1st; and

WHEREAS, the District submitted its proposed Fiscal Year 2019/2020 budget, which was approved by the City Council Ordinance 2019-207-E, that set the non-ad valorem assessment per parcel at \$850.00; and

WHEREAS, on August 14, 2019, the District adopted Resolution 19-04 which increased the non-ad valorem assessment to be levied on property from \$850.00 per parcel to \$950.00 per parcel; and

WHEREAS, the Isle of Palms Special District has submitted the amended Fiscal Year 2019/2020 budget to the City Council for approval pursuant to Ordinance 2011-724-E, a copy of the Board Resolution is attached hereto as Exhibit 1; and

WHEREAS, the City Council finds that the Isle of Palms Special
