States Environmental Protection Agency funded by the

Inflation Reduction Act of 2022. The grant funds will be used to procure equipment for the expansion and enhancement of air monitoring activities. The grant period commenced on October 1, 2024 and ends December 31, 2028. No local match is required.

6 Section 2. Purpose. The purpose of the appropriation in 7 Section 1 is to expand and enhance air monitoring activities and conduct mobile monitoring to identify Volatile Organic Compound (VOC) 8 9 plumes and VOC air toxic hotspots in disadvantaged communities, 10 particularly Jacksonville's Health Zone 1 who face disproportionate exposure to air pollutants resulting in an increased vulnerability 11 This project will revolutionize the City's 12 for health risks. understanding of air quality issues and its impact on public health 13 in vulnerable areas of the City.
