5 AN ORDINANCE APPROPRIATING \$1,500,000 IN  
6 COMMUNITY DEVELOPMENT BLOCK GRANT DISASTER  
7 RECOVERY ("CDBG-DR") FUNDS FROM THE U.S.  
8 DEPARTMENT OF HOUSING AND URBAN DEVELOPMENT  
9 THROUGH THE STATE OF FLORIDA, DEPARTMENT OF  
10 ECONOMIC OPPORTUNITY, TO PROVIDE HOUSING  
11 REHABILITATION SERVICES FOR ELIGIBLE SINGLE-  
12 FAMILY PROPERTIES DAMAGED BY HURRICANE MATTHEW,  
13 AS INITIATED BY B.T. 22-049; PURPOSE OF THE  
14 APPROPRIATION; APPROVING AND AUTHORIZING THE  
15 MAYOR, OR HIS DESIGNEE, AND CORPORATION  
16 SECRETARY TO EXECUTE AND DELIVER, FOR AND ON  
17 BEHALF OF THE CITY, THAT CERTAIN AMENDMENT TWO  
18 TO SUBRECIPIENT AGREEMENT BETWEEN THE DEPARTMENT  
19 OF ECONOMIC OPPORTUNITY AND CITY OF  
20 JACKSONVILLE, FLORIDA; PROVIDING FOR OVERSIGHT  
21 BY THE NEIGHBORHOODS DEPARTMENT, HOUSING AND  
22 COMMUNITY DEVELOPMENT DIVISION; PROVIDING AN  
23 EFFECTIVE DATE.

25 **BE IT ORDAINED** by the Council of the City of Jacksonville:

26 **Section 1. Appropriation.** For the 2021-2022 fiscal year,  
27 within the City's budget, there are hereby appropriated the indicated  
28 sum(s) from the account(s) listed in subsection (a) to the account(s)  
29 listed in subsection (b):

5 (c) Explanation of Appropriation:

6 The funding above is an appropriation of \$1,500,000 in  
7 additional Community Development Block Grant Disaster  
8 Recovery ("CDBG-DR") funds from the U.S. Department of  
9 Housing and Urban Development ("HUD"), through the Florida  
10 Department of Economic Opportunity, for housing  
11 rehabilitation services as described in this Ordinance.  
12 This brings the total CDBG-DR funding provided to the City  
13 through this grant to \$4,590,513.58. No City match is  
14 required.

15 **Section 2. Purpose.** The purpose of the appropriation in  
16 Section 1 is to provide housing rehabilitation services to eligible  
17 single-family properties that were damaged by Hurricane Matthew and  
18 that are unable to be rehabilitated using other funding sources.  
19 Necessary home repairs may be provided in the form of rehabilitation  
20 or demolition and reconstruction of existing housing units. All  
21 households receiving assistance through the CDBG-DR program will be  
22 low- to moderate-income households with incomes not exceeding 80% of  
23 the current area median income established by HUD.

24 **Section 3. Approval and Authorization to Execute.** The  
25 Mayor, or his designee, and the Corporation Secretary are hereby  
26 authorized to execute and deliver on behalf of the City, that certain  
27 Amendment Two to Subrecipient Agreement Between the Department of  
28 Economic Opportunity and City of Jacksonville, Florida ("Amendment  
29 Two"), attached hereto as **Exhibit 2** and incorporated herein by this  
30 reference, which amends the State of Florida, Department of Economic  
31 Opportunity Federally-Funded Community Development Block Grant
