Section 2. Purpose. The purpose of the appropriation in Section 1 is to provide funds for the Mayor's Council on Fitness and Well-Being (the "Council") to retain the services of a consultant to assist the Council in development of a strategic plan for community wellness. The Council was created in 1987 by Executive Order of Mayor Thomas L. ("Tommy") Hazouri as an official agency of the City tasked to evaluate, coordinate, initiate and promote fitness and well-being opportunities, facilities and awareness in the City of Jacksonville. The strategic plan to be developed with the assistance of a consultant is intended to outline opportunities and pathways forward in furtherance of the Council's mission.
