**ORDINANCE 2025-645**

AN ORDINANCE APPROPRIATING \$51,227 FROM THE SPECIAL COUNCIL CONTINGENCY ACCOUNT TO THE COUNCIL FOR FITNESS AND WELL-BEING - OTHER PROFESSIONAL SERVICES ACCOUNT, TO PROVIDE FUNDING FOR THE MAYOR'S COUNCIL ON FITNESS AND WELL-BEING (THE "COUNCIL") TO RETAIN THE SERVICES OF A CONSULTANT TO ASSIST THE COUNCIL IN THE DEVELOPMENT OF A STRATEGIC PLAN FOR COMMUNITY WELLNESS; PROVIDING FOR CARRYOVER; PROVIDING AN EFFECTIVE DATE.

**BE IT ORDAINED** by the Council of the City of Jacksonville:

**Section 1. Appropriation.** For the 2024-2025 fiscal year, within the City's budget, there is hereby appropriated the indicated sum(s) from the account(s) listed in subsection (a) to the account(s) listed in subsection (b):

(c) Explanation of Appropriation:

The funding above represents an appropriation of \$51,227 from the Special Council Contingency account to the Council for Fitness and Well-Being - Other Professional Services account, to provide funding for the Mayor's Council on

1 Fitness and Well-Being to retain the services of a  
2 consultant to assist with development of a strategic plan  
3 for community wellness.

4 **Section 2. Purpose.** The purpose of the appropriation in  
5 Section 1 is to provide funds for the Mayor's Council on Fitness and  
6 Well-Being (the "Council") to retain the services of a consultant to  
7 assist the Council in development of a strategic plan for community  
8 wellness. The Council was created in 1987 by Executive Order of  
9 Mayor Thomas L. ("Tommy") Hazouri as an official agency of the City  
10 tasked to evaluate, coordinate, initiate and promote fitness and  
11 well-being opportunities, facilities and awareness in the City of  
12 Jacksonville. The strategic plan to be developed with the assistance  
13 of a consultant is intended to outline opportunities and pathways  
14 forward in furtherance of the Council's mission.

15 **Section 3. Carryover.** The funds appropriated herein shall  
16 not lapse but shall carryover to fiscal year 2025-2026.

17 **Section 4. Effective Date.** This Ordinance shall become  
18 effective upon signature by the Mayor or upon becoming effective  
19 without the Mayor's signature.
