5 AN ORDINANCE APPROPRIATING \$300,000.00 FROM THE  
6 METROPOLITAN PARK MAINTENANCE SUBFUND (1D4) FUND  
7 BALANCE TO BE USED FOR DEMOLITION OF MOBILE  
8 OFFICE TRAILERS AND THE STAGE, STAGE BUILDING,  
9 AND STAGE FLOORING AND CONCRETE FOUNDATION, AND  
10 FOR RESTORATION OF SIDEWALK CONNECTIONS, AS  
11 INITIATED BY B.T. 21-108; PURPOSE OF  
12 APPROPRIATION; PROVIDING AN EFFECTIVE DATE.

14 **BE IT ORDAINED** by the Council of the City of Jacksonville:

15 **Section 1. Appropriation.** For the 2021-2022 fiscal year,  
16 within the City's budget, there are hereby appropriated the indicated  
17 sum(s) from the account(s) listed in subsection (a) to the account(s)  
18 listed in subsection (b):

25 (c) Explanation of appropriation:

26 The funding above is an appropriation of revenue from the  
27 Metropolitan Park Maintenance Subfund (1D4) fund balance  
28 to cover operating and maintenance expenses for  
29 Metropolitan Park and its various facilities (the "Park").  
30 The Metropolitan Park Maintenance and Improvements Fund,  
31 Section 111.120, *Ordinance Code*, is a permanent trust fund

1 for all revenues received by the City in connection with  
2 admission fees for special events, rentals, dock slip  
3 rentals, equipment and service charges, and other funds  
4 from activities and events conducted or authorized by the  
5 City in the Park.

6 **Section 2. Purpose.** The purpose of the appropriation in  
7 Section 1 is to provide funds for the demolition of mobile office  
8 trailers and the old stage, including demolition of the stage  
9 building, stage flooring, stage concrete foundation, and associated  
10 concrete pavement. These funds will also be used to restore concrete  
11 sidewalk connections.

12 **Section 3. Effective Date.** This Ordinance shall become  
13 effective upon signature by the Mayor or upon becoming effective  
14 without the Mayor's signature.
