5 AN ORDINANCE APPROPRIATING \$114,945.97 FROM THE
6 SPECIAL LAW ENFORCEMENT TRUST FUND (THE "FUND")
7 TO FUND VARIOUS CRIME PREVENTION AND LAW
8 ENFORCEMENT EXPENDITURES AND ACTIVITIES
9 INCLUDING: (1) TRANSFERRING \$7,500.00 FROM THE
10 FUND TO THE TEEN DRIVER SPECIAL REVENUE FUND IN
11 ACCORDANCE WITH SECTION 111.365, *ORDINANCE CODE*,
12 TO FUND THE TEEN DRIVER CHALLENGE PROGRAM; (2)
13 TRANSFERRING \$7,500.00 FROM THE FUND TO THE
14 POLICE EXPLORERS TRUST FUND IN ACCORDANCE WITH
15 SECTION 111.340, *ORDINANCE CODE*, TO FUND THE
16 JACKSONVILLE SHERIFF'S OFFICE ("JSO") POLICE
17 EXPLORER POST; (3) TRANSFERRING \$20,000.00 TO BE
18 USED FOR THE HOMEWARD BOUND PROGRAM; AND (4)
19 \$79,945.97 FOR DONATIONS TO HUBBARD HOUSE, INC.
20 (\$9,945.97), NORTH FLORIDA COUNCIL, INC., BOY
21 SCOUTS OF AMERICA (\$10,000.00), OPERATION SAVE
22 OUR SONS, INC. (\$15,000.00), M.A.D. D.A.D.S.,
23 JACKSONVILLE CHAPTER, INC. (\$15,000.00), BIG
24 BROTHERS BIG SISTERS OF NORTHEAST FLORIDA, INC.
25 (\$5,000.00), AND DOWNTOWN VISION ALLIANCE, INC.
26 (\$25,000.00) (THE "DONEES"), IN ACCORDANCE WITH
27 SECTION 932.7055(5), FLORIDA STATUTES, AS
28 INITIATED BY B.T. 24-092; APPROVING, AND
29 AUTHORIZING THE MAYOR, OR HER DESIGNEE, AND THE
30 CORPORATION SECRETARY TO EXECUTE AND DELIVER ON
31 BEHALF OF THE CITY CERTAIN MISCELLANEOUS

1 APPROPRIATIONS AGREEMENTS BETWEEN THE CITY OF
2 JACKSONVILLE AND EACH OF THE DONEES
3 RESPECTIVELY; WAIVING SECTION 110.112 (ADVANCE
4 OF CITY FUNDS; PROHIBITION AGAINST), PART 1 (THE
5 CITY TREASURY), CHAPTER 110 (CITY TREASURY),
6 ORDINANCE CODE, TO ALLOW FOR ADVANCE PAYMENT TO
7 THE DONEES; PROVIDING FOR OVERSIGHT BY THE
8 JACKSONVILLE SHERIFF'S OFFICE; PROVIDING AN
9 EFFECTIVE DATE.

11 **BE IT ORDAINED** by the Council of the City of Jacksonville:

12 **Section 1. Appropriation.** For the 2023-2024 fiscal year,
13 within the City's budget, there is hereby appropriated the indicated
14 sum(s) from the account(s) listed in subsection (a) to the account(s)
15 listed in subsection (b):

17 this reference)

22 (c) Explanation of Appropriation:

23 The funding above represents an appropriation of
24 \$114,945.97 in Contributions from Private Sources within
25 the Special Law Enforcement Trust Fund (the "Fund") to
26 other City funds for various crime prevention and law
27 enforcement expenditures and activities and for donations
28 to various organizations set forth herein, in accordance
29 with the *Ordinance Code* and Section 932.7055, *Florida*
30 *Statutes*, as more specifically outlined herein.

31 **Section 2. Purpose.** The purpose of the appropriation in

1 Section 1 is to transfer \$7,500.00 from the Fund to the Teen Driver
2 Special Revenue Fund for the Teen Driver Challenge Program in
3 accordance with Section 111.365, *Ordinance Code*; transfer \$7,500.00
4 from the Fund to the Police Explorers Trust Fund for the JSO Police
5 Explorer Post in accordance with Section 111.340, *Ordinance Code*;
6 transfer \$20,000.00 to the Homeward Bound Program, and transfer
7 \$79,945.97 to Hubbard House, Inc. (\$9,945.97), North Florida Council,
8 Inc., Boy Scouts of America (\$10,000.00), Operation Save Our Sons,
9 Inc. (\$15,000.00), M.A.D.D.A.D.S., Jacksonville Chapter, Inc.
10 (\$15,000.00), Big Brothers Big Sisters of Northeast Florida, Inc.
11 (\$5,000.00), and Downtown Vision, Inc. (\$25,000.00), to support drug
12 treatment, drug abuse education, drug prevention, crime prevention,
13 safe neighborhood, or school resource officer programs, and other law
14 enforcement purposes. A Certification from the Jacksonville Sheriff's
15 Office that the subject appropriation from the Special Law Enforcement
16 Trust Fund complies with Section 932.7055, *Florida Statutes*, is
17 attached hereto as **Exhibit 2** and incorporated herein by this
18 reference.

19 **Section 3. Approval and Authorization.** There is hereby
20 approved, and the Mayor, or her designee, and the Corporation
21 Secretary are hereby authorized to execute and deliver on behalf of
22 the City those certain Miscellaneous Appropriations Agreements
23 between the City of Jacksonville and Hubbard House, Inc., North
24 Florida Council, Inc., Boy Scouts of America, Operation Save Our
25 Sons, Inc., M.A.D. D.A.D.S., Jacksonville Chapter, Inc., Big Brothers
26 Big Sisters of Northeast Florida, Inc., and Downtown Vision Alliance,
27 Inc. (the "Donees"), respectively, in substantially the forms placed
28 **On File** with the Legislative Services Division and incorporated herein
29 by this reference (the "Agreements").

30 **Section 4. Waiving Section 110.112, Ordinance Code.**
31 Section 110.112 (Advance of City funds; prohibition against), Part 1

1 (The City Treasury), Chapter 110 (City Treasury), *Ordinance Code*, is
2 hereby waived to allow for advance payment to the Donees as provided
3 in the Agreements.

4 **Section 5. Oversight.** The Jacksonville Sheriff's Office
5 shall oversee the Agreements described herein.

6 **Section 6. Effective Date.** This Ordinance shall become
7 effective upon signature by the Mayor or upon becoming effective
8 without the Mayor's signature.
