**1. DEMES Access**

- Subrecipient organization name (as it will appear on the agreement)
- Delegation of Authority for the Grant Manager
- Unique Entity Identifier (UEI#)
- Financial Vendor Sequence Number to include the last 3-digits.
- Position title
- Email address
- Phone number

**2. MyFloridaMarketPlace (MFMP) Registration**

Your organization must maintain an active registration in MyFloridaMarketPlace (MFMP). The three-digit Financial Vendor Sequence Number may be obtained through MFMP.

**3. Active UEI/SAM Registration**

Your organization must obtain and maintain an active Unique Entity Identifier (UEI) in [SAM.gov](https://sam.gov) at the time of award and throughout the grant period of performance.

You will receive notification in the coming weeks when your agreement is available to review and retrieval in DEMES.
