**ORDINANCE** 2023-795

AN ORDINANCE REGARDING CHAPTER 745 (ADDRESSING AND STREET NAMING REGULATIONS) ORDINANCE CODE; ESTABLISHING AN HONORARY STREET DESIGNATION AND ASSOCIATED ROADWAY MARKERS FOR "HISTORIC FLORIDA AVENUE" RE-NAMED, IN 1994, AS "A. PHILIP RANDOLPH BOULEVARD" BETWEEN BAY STREET AND FIRST STREET;" ESTABLISHING AN HONORARY DESIGNATION ON A. PHILIP RANDOLPH BOULEVARD EXTENDING FROM BEAVER STREET TO FIRST STREET EAST IN COUNCIL DISTRICT 7 FOR "HISTORIC FLORIDA AVENUE"; PROVIDING FOR THE INSTALLATION OF TWO HONORARY ROADWAY MARKERS TO BE LOCATED IN APPROPRIATE LOCATIONS ON THE DESIGNATED ROAD IN COUNCIL DISTRICT 7; WAIVER OF SECTION 745.105 (I) (1) - (3) AND (J) (3) WHICH REQUIRES THAT AN HONOREE ACHIEVED PROMINENCE, BE DECEASED FOR FIVE YEARS, LIVE IN THE COMMUNITY WITHIN FIVE MILES OF THE STREET BEING DESIGNATED FOR AT LEAST 10 YEARS AND BE A DECEASED PERSON; DIRECTING THE LEGISLATIVE SERVICES DIVISION TO FORWARD THIS ORDINANCE TO THE PLANNING AND DEVELOPMENT DEPARTMENT, ADDRESSING DIVISION FOR PROCESSING, IMPLEMENTATION AND COORDINATION THE PUBLIC WORKS DEPARTMENT, TRAFFIC ENGINEERING AND OTHER AFFECTED AGENCIES AND ORGANIZATIONS; PROVIDING AN EFFECTIVE DATE.

WHEREAS, on June 28, 1994, the Jacksonville City Council enacted

Ordinance No. 94-459-338 and re-named "Florida Avenue" to "A. Philip Randolph Boulevard" due to Mr. Randolph's notable achievements and efforts for equality, fairness and opportunity for all especially the Brotherhood of Sleeping Car Porters; and

WHEREAS, prior to the re-naming, "Florida Avenue" was home to a number of historic walkable neighborhood commercial districts (Source: "Walkable Jacksonville: The Avenue" by Ennis Davis, AICP, November 29, 2020); and

WHEREAS, in the 1920's, historic "Florida Avenue" was known as "The Avenue"--a center of African American commerce; and

WHEREAS, historic "Florda Avenue" was connected via a streetcar line running down the center of "Florida Avenue" connecting residents living, primarily, between the Jacksonville Shipyards and East 8th Street; and

WHEREAS, having a potential 100 walkable score, historic "Florida Avenue" also consisted of mixed-use buildings including mom and pop businesses, restaurants and entertainment venues, to wit: the Blue Ridge Inn, Charlie Joseph's grocery store, Johns Furniture and Bill's Clothing; and

WHEREAS, famous residents living on or near historic "Florida Avenue" were A. Philip Randolph, Zora Neale Hurston, A.L. Lewis and Bullet Bob Hayes;

WHEREAS, in the 1960s, historic "Florida Avenue" suffered damage to numerous buildings as a result of a major hurricane and racial protests; and

WHEREAS, over the years, historic "Florida Avenue" has been active under the street name of "A. Philip Randolph Boulevard" and numerous sports and entertainment events held at the stadium nearby; and

WHEREAS, pursuant to Section 745.105 (j)(10), Ordinance Code, the Planning and Development Department mailed written notifications

on August 8, 2023, and on September 11, 2023, to 45 affected property owners requesting written consent or objection to the proposed honorary street designation. A copy of the first and second written notifications and a complete listing of the 45 total affected addresses are attached as **Exhibits 1, 2** and **3;** and

WHEREAS, six (6) affected property owners indicated their consent of the proposed honorary designation. Copies of the written consents are attached as Exhibit 4; and

WHEREAS, one (1) affected property owner objected to the proposed honorary designation. A copy of the written objection is attached as Exhibit 4; and

WHEREAS, pursuant to Section 745.105 (j)(10), Ord. Code, the remaining affected property owners are deemed to have consented to the proposed honorary designations due to their non-response to the written notifications; and

BE IT ORDAINED by the Council of the City of Jacksonville:

Section 1. A. Philip Randolph Boulevard to receive an honorary street designation for "Historic Florida Avenue" extending from Beaver Street to First Street East in Council District 7, is hereby designated as contemplated by Section 745.105, Ordinance Code, for "Historic Florida Avenue." A map of the road designation is attached hereto as Exhibit 5.

Section 2. Honorary Roadside Markers for "Historic Florida Avenue" to be installed. Two honorary roadside markers, as contemplated by Section 745.105, Ordinance Code, recognizing "Historic Florida Avenue" shall be placed in appropriate locations on A. Philip Randolph Boulevard.

Section 3. Waiver of Section 745.105 (i) (1)-(3) and (j) (3), Ordinance Code. Section 745.105(i) (1)-(3) and (j) (3) which requires that the honoree (1) achieved prominence, (2) be deceased for five years, (3) live in the community within five miles of the designated
