5 AN ORDINANCE APPROPRIATING \$1,042,000.00 FROM
6 THE COUNTYWIDE BRIDGES PROJECT TO FUND TWO NAMED
7 PROJECTS, WITH \$792,000.00 TO FUND YELLOW BLUFF
8 ROAD BRIDGE REPAIRS, AND \$250,000.00 TO FUND THE
9 NEW BERLIN GUARDRAILS PROJECT, AS INITIATED BY
10 B.T. 24-027; PURPOSE OF APPROPRIATION; AMENDING
11 THE 2024-2028 FIVE-YEAR CAPITAL IMPROVEMENT PLAN
12 APPROVED BY ORDINANCE 2023-505-E TO REFLECT THIS
13 APPROPRIATION OF FUNDS; PROVIDING AN EFFECTIVE
14 DATE.

16 **BE IT ORDAINED** by the Council of the City of Jacksonville:

17 **Section 1. Appropriation.** For the 2023-2024 fiscal year,
18 within the City's budget, there is hereby appropriated the indicated
19 sum(s) from the account(s) listed in subsection (a) to the account(s)
20 listed in subsection (b):

27 (c) Explanation of Appropriation:

28 The funding above represents an appropriation of funds from
29 the Countywide Bridges Project to fund two named projects,
30 with \$792,000.00 to fund Yellow Bluff Road Bridge Repair,
31 and \$250,000 to fund the New Berlin Guardrails Project.

1 **Section 2. Purpose.** The purpose of the appropriation in
2 Section 1 is to provide funding of \$792,000.00 to the Yellow Bluff
3 Road Bridge Repairs to upgrade guardrails to FDOT standards, fill
4 voids under the north approach slab, and replace the timber retaining
5 wall under the bridge. \$250,000.00 will be transferred to the New
6 Berlin Guardrails Project to repair and restore damaged guardrail on
7 New Berlin Road between Starratt Road and Dunn Creek Road.

8 **Section 3. Capital Improvement Plan Amendment.** Ordinance
9 2023-505-E, adopting the 2024-2028 Five-Year Capital Improvement Plan
10 (the "CIP") for the City and certain of its independent agencies, is
11 hereby amended to reflect this reallocation of funds as described in
12 **Exhibit 2** attached hereto and incorporated herein by this reference.
13 The City Council finds that the deferral of this amendment of the CIP
14 until the next annual budget and CIP review will be detrimental to
15 the best interests of the community because such deferral will
16 unnecessarily delay completion of the projects.

17 Pursuant to Section 122.605(c), *Ordinance Code*, enactment of
18 this Ordinance requires the affirmative vote of two-thirds of the
19 City Council members present at the meeting because of the CIP
20 amendment set forth in this section. This Ordinance shall constitute
21 an amendment to Ordinance 2023-505-E. In all other respects, the
22 Five-Year Capital Improvement Plan approved by Ordinance 2023-505-E
23 shall remain unchanged and continue in full force and effect.

24 **Section 4. Effective Date.** This Ordinance shall become
25 effective upon signature by the Mayor or upon becoming effective
26 without the Mayor's signature.
