5 AN ORDINANCE APPROPRIATING \$1,813,518.84 FROM
6 INSURED PROGRAMS RETAINED EARNINGS AND
7 MISCELLANEOUS INSURED PROGRAMS - PREMIUM PAID GL
8 AUTO, POLICY & MISC., AVIATION, RIVER WALK-CITY,
9 BLANKET CRIME-CITY AND CYBER LIABILITY ACCOUNTS
10 TO PAY ADDITIONAL PROPERTY AND OTHER INSURANCE
11 PREMIUM COSTS, AS INITIATED BY B.T. 23-072;
12 REQUESTING ONE CYCLE EMERGENCY PASSAGE;
13 PROVIDING FOR AN EFFECTIVE DATE.

15 **BE IT ORDAINED** by the Council of the City of Jacksonville:

16 **Section 1. Appropriation.** For the 2022-2023 fiscal year,
17 within the City's budget, there is hereby appropriated the indicated
18 sum from the account listed in subsection (a) to the account listed
19 in subsection (b):

26 (c) Explanation of Appropriation:

27 The funding above comprises an appropriation of
28 \$1,813,518.84 from Insured Programs Retained Earnings and
29 Miscellaneous Insured Programs - Premium Paid GL Auto,
30 Policy & Misc., Aviation, River Walk-City, Blanket Crime-
31 City and Cyber Liability accounts to pay additional

1 Property and other insurance premium costs.

2 **Section 2. Purpose.** The purpose of the appropriation in
3 Section 1 is to appropriate a total of \$1,813,518.84 from Insured
4 Programs Retained Earnings (\$1,479,933.84) and Miscellaneous Insured
5 Programs - Premium Paid GL Auto, Policy & Misc., Aviation, River
6 Walk-City, Blanket Crime-City, and Cyber Liability accounts
7 (\$333,585.00) to pay additional premium costs for Property and various
8 other miscellaneous insurance policies for continued coverage through
9 the current fiscal year. This appropriation is necessary because the
10 budgeted amount for these premiums for fiscal year 2022-2023 is lower
11 than the actual expenses.

12 **Section 3. Requesting One Cycle Emergency Passage Pursuant**
13 **to Council Rule 4.901 Emergency.** One cycle emergency passage of this
14 legislation is requested. The nature of the emergency is that the
15 premium payments are due April 12, 2023 and the City wants to ensure
16 the payments can be made timely.

17 **Section 4. Effective Date.** This Ordinance shall become
18 effective upon signature by the Mayor or upon becoming effective
19 without the Mayor's signature.
