7 A RESOLUTION CONFIRMING THE MAYOR'S APPOINTMENT
8 OF DANIEL BLANCHARD, A DUVAL COUNTY RESIDENT, TO
9 THE JACKSONVILLE HOUSING AUTHORITY, REPLACING
10 LISA STRANGE WEATHERBY, PURSUANT TO SECTION
11 51A.103 (APPOINTMENT, QUALIFICATIONS, AND
12 TENURE OF COMMISSIONERS; HIRING OF EMPLOYEES),
13 CHAPTER 51A (JACKSONVILLE HOUSING AUTHORITY),
14 *ORDINANCE CODE*, FOR A PARTIAL TERM TO EXPIRE ON
15 SEPTEMBER 16, 2026, FOLLOWED BY A FIRST FULL
16 TERM TO EXPIRE ON SEPTEMBER 16, 2030; REQUESTING
17 ONE CYCLE EMERGENCY PASSAGE; PROVIDING AN
18 EFFECTIVE DATE.

20 **BE IT RESOLVED** by the Council of the City of Jacksonville:

21 **Section 1. Confirmation.** The Council hereby confirms the
22 Mayor's appointment of Daniel Blanchard, a Duval County resident, to
23 the Jacksonville Housing Authority, replacing Lisa Strange Weatherby,
24 pursuant to Section 51A.103 (Appointment, qualifications, and tenure
25 of commissioners; hiring of employees), Chapter 51A (Jacksonville
26 Housing Authority), *Ordinance Code*, for a partial term to expire on
27 September 16, 2026, followed by a first full term to expire on
28 September 16, 2030.

29 **Section 2. Requesting One Cycle Emergency Passage Pursuant**
30 **to Council Rule 4.901 (Requesting Emergency Passage).** One cycle
31 emergency passage of this legislation is requested. The nature of the

1 emergency is that the Jacksonville Housing Authority requires
2 additional board members to fill vacant seats as soon as possible to
3 facilitate its ability to conduct board business.

4 **Section 3. Effective Date.** This Resolution shall become
5 effective upon signature by the Mayor or upon becoming effective
6 without the Mayor's signature.
