6 A RESOLUTION CONFIRMING THE APPOINTMENT OF CHRYS  
7 YATES, A DUVAL COUNTY RESIDENT, AS A MEMBER OF  
8 THE CULTURAL SERVICE GRANT PROGRAM COMMITTEE, AS  
9 ONE OF THE SEVEN COMMUNITY REPRESENTATIVES,  
10 REPLACING AMY CRANE, PURSUANT TO SECTION  
11 118.605, *ORDINANCE CODE*, FOR A PARTIAL TERM  
12 EXPIRING DECEMBER 31, 2025; REQUESTING ONE CYCLE  
13 EMERGENCY PASSAGE; PROVIDING AN EFFECTIVE DATE.

15 **WHEREAS**, pursuant to Section 118.605(a), *Ordinance Code*, the  
16 membership of the Cultural Service Grant Program Committee ("CSGP")  
17 shall include one non-voting and ten voting members: a CSGP Committee  
18 chairperson (non-voting), appointed by the President of the Cultural  
19 Council Board of Directors; three other Cultural Council Board members  
20 selected by the Board President and Committee Chairperson; and seven  
21 individuals selected by the above group (Cultural Council Board  
22 President, CSGP Committee chairperson, and three selected Cultural  
23 Council Board members); and

24 **WHEREAS**, pursuant to Section 118.605(d), *Ordinance Code*, all  
25 members of the Cultural Service Grant Program Committee shall be  
26 confirmed by the City Council; now therefore

27 **BE IT RESOLVED** by the Council of the City of Jacksonville:

28 **Section 1. Confirmation.** The Council hereby confirms the  
29 appointment of Chrys Yates, a Duval County resident, to the Cultural  
30 Service Grant Program Committee, replacing Amy Crane, as one of the  
31 seven community representatives, pursuant to Section 118.605,

1 *Ordinance Code*, for a partial term expiring December 31, 2025.

2           **Section 2.           Requesting One Cycle Emergency Passage Pursuant**  
3 **to Council Rule 4.901 Emergency.** One cycle emergency passage of this  
4 legislation is requested to enable the appointee to be seated in time  
5 to participate in the Cultural Service Grant Program Committee's  
6 Capital Grants process in January.

7           **Section 3.           Effective Date.** This Resolution shall become  
8 effective upon signature by the Mayor or upon becoming effective  
9 without the Mayor's signature.
