5 AN ORDINANCE APPROPRIATING \$90,000.00 FROM THE  
6 LOBLOLLY WETLANDS MITIGATION FUND ACCOUNT TO  
7 THE SOUTHEAST REGIONAL PARK DEVELOPMENT  
8 (PALMETTO LEAVES PARK) ACCOUNT FOR THE  
9 CONSTRUCTION OF 500 LINEAR FEET OF WOODEN  
10 BOARDWALK AT THE PALMETTO LEAVES REGIONAL  
11 PARK, AS INITIATED BY B.T. 19-082; PROVIDING A  
12 CARRYOVER OF FUNDS FROM YEAR TO YEAR UNTIL  
13 BOARDWALK CONSTRUCTION IS COMPLETED; PROVIDING  
14 AN EFFECTIVE DATE.

15 **BE IT ORDAINED** by the Council of the City of Jacksonville:

16 **Section 1. Appropriation.** For the 2018-2019 fiscal year,  
17 within the City's budget, there are hereby appropriated the  
18 indicated sum(s) from the account(s) listed in subsection (a) to  
19 the account(s) listed in subsection (b):

26 (c) **Explanation of Appropriation**

27 The funding above is a transfer from the Loblolly  
28 Wetlands Mitigation Fund account to the Southeast  
29 Regional Park Development (Palmetto Leaves Park) account  
30 for the construction of 500 linear feet of wooden  
31 boardwalk at the Palmetto Leaves Regional Park in

1           accordance with Section 111.780 (Loblolly Wetlands  
2           Mitigation Special Revenue Fund), *Ordinance Code*.

3           **Section 2. Carryover.**       The funds appropriated in  
4 Section 1 of this ordinance shall not lapse but shall carryover  
5 from year to year until boardwalk construction is completed.

6           **Section 3. Purpose.**       The purpose of the appropriation in  
7 Section 1 is to provide funds for the construction of 500 linear  
8 feet of boardwalk at the Palmetto Leaves Regional Park.

9           **Section 4. Effective Date.**   This ordinance shall become  
10 effective upon signature by the Mayor or upon becoming effective  
11 without the Mayor's signature.
