## ORDINANCE 2024-237-E

AN ORDINANCE APPROVING, SUBJECT TO CONDITIONS, APPLICATION FOR ZONING EXCEPTION E-24-12 FOR PROPERTY LOCATED IN COUNCIL DISTRICT 7 AT 901 KING STREET, BETWEEN KING STREET AND COLLEGE (R.E. NO. 064197-0010), AS DESCRIBED STREET HEREIN, OWNED BY IHOP LKE RMR LLC, REQUESTING AN ESTABLISHMENT OR FACILITY WHICH INCLUDES THE RETAIL SALE AND SERVICE OF ALL ALCOHOLIC BEVERAGES INCLUDING LIQUOR, BEER OR WINE FOR ON-PREMISES CONSUMPTION FOR ENTITY OF LOVE LLC, IN ZONING DISTRICTS COMMERCIAL COMMUNITY/GENERAL-1 (CCG-1) AND PLANNED UNIT DEVELOPMENT (PUD) (2012-504-E), AS DEFINED AND CLASSIFIED UNDER THE ZONING CODE; ADOPTING RECOMMENDED FINDINGS AND CONCLUSIONS OF THE LAND USE AND ZONING COMMITTEE; PROVIDING FOR DISTRIBUTION; PROVIDING AN EFFECTIVE DATE.

WHEREAS, an application for a zoning exception, On File with the City Council Legislative Services Division, was filed by Jessica Tyree for Entity of Love LLC, on behalf of the owner of property located in Council District 7 at 901 King Street, between King Street and College Street (R.E. No. 064197-0010) (the "Subject Property"), requesting an establishment or facility which includes the retail sale and service of all alcoholic beverages including liquor, beer or wine for on-premises consumption in Zoning Districts Commercial Community/General-1 (CCG-1) and Planned Unit Development (PUD)

(2012-504-E); and

WHEREAS, the Planning and Development Department has considered the application and all attachments thereto and has rendered an advisory recommendation; and

WHEREAS, the Land Use and Zoning Committee, after due notice, held a public hearing and having duly considered both the testimonial and documentary evidence presented at the public hearing, has made its recommendation to the Council; now therefore

Section 1. Adoption of Findings and Conclusions. The Council has considered the recommendation of the Land Use and Zoning Committee and reviewed the Staff Report of the Planning and Development Department concerning application for zoning exception E-24-12. Based upon the competent, substantial evidence contained in the record, the Council hereby determines that the requested zoning exception meets each of the following criteria required to grant the request pursuant to Section 656.131(c), Ordinance Code, as specifically identified in the Staff Report of the Planning and Development Department:

- (1) Will be consistent with the Comprehensive Plan, including any subsequent plan adopted by the Council pursuant thereto;
- (2) Will be compatible with the existing contiguous uses or zoning and compatible with the general character of the area, considering population density, design, scale and orientation of structures to the area, property values, and existing similar uses or zoning;
- (3) Will not have an environmental impact inconsistent with the health, safety and welfare of the community;
- (4) Will not have a detrimental effect on vehicular or pedestrian traffic, or parking conditions, and will not result in the generation or creation of traffic inconsistent with the health, safety and

welfare of the community;

- (5) Will not have a detrimental effect on the future development of contiguous properties or the general area, according to the Comprehensive Plan, including any subsequent amendment to the plan adopted by the Council;
- (6) Will not result in the creation of objectionable or excessive noise, lights, vibrations, fumes, odors, dust or physical activities, taking into account existing uses or zoning in the vicinity;
  - (7) Will not overburden existing public services and facilities;
- (8) Will be sufficiently accessible to permit entry onto the property by fire, police, rescue and other services; and
- (9) Will be consistent with the definition of a zoning exception, and will meet the standards and criteria of the zoning classification in which such use is proposed to be located, and all other requirements for such particular use set forth elsewhere in the Zoning Code, or otherwise adopted by the Planning Commission or Council.

Therefore, zoning exception application E-24-12 is hereby approved subject to the following conditions:

- (1) The use granted hereby shall be limited to a maximum of 151 total seats.
- (2) The hours of operation shall be limited to between 6:00 a.m. and 11:00 p.m. The hours of operation shall be posted on the front of the restaurant.
  - (3) Outdoor music and/or amplified sound is prohibited.
- Section 2. Owner and Description. The Subject Property is owned by IHOP LKE RMR LLC and is described in **Exhibit 1**, dated January 10, 2024, and graphically depicted in **Exhibit 2**, both attached hereto.
