ORDINANCE 2025-602

AN ORDINANCE APPROPRIATING \$32,000.00 FROM THE SPECIAL LAW ENFORCEMENT TRUST FUND (THE "FUND") TO FUND CRIME PREVENTION AND LAW ENFORCEMENT EXPENDITURES AND ACTIVITIES INCLUDING: (1) TRANSFERRING \$2,000.00 FROM THE FUND TO FLORIDA SHERIFFS YOUTH RANCHES, INC., AND (2) TRANSFERRING \$30,000.00 FROM THE FUND TO DOWNTOWN VISION ALLIANCE, INC. FOR THE HOMEWARD BOUND PROGRAM, AS INITIATED BY B.T. 25-105; PROVIDING FOR OVERSIGHT BY THE JACKSONVILLE SHERIFF'S OFFICE; AUTHORIZING THE MAYOR, OR HER DESIGNEE, AND THE CORPORATION SECRETARY TO EXECUTE AND DELIVER DOCUMENTS RELATING TO THE APPROPRIATION; PROVIDING AN EFFECTIVE DATE.

BE IT ORDAINED by the Council of the City of Jacksonville:

Section 1. Appropriation. For the 2024-2025 fiscal year, within the City's budget, there is hereby appropriated the indicated sum(s) from the account(s) listed in subsection (a) to the account(s) listed in subsection (b):

1 The funding above represents an appropriation of \$32,000
2 from within the Special Law Enforcement Trust Fund (the
3 "Fund") to the organizations as set forth herein to support
4 crime prevention and law enforcement expenditures and
5 activities.

6 **Section 2. Purpose.** The purpose of the appropriation in
7 Section 1 is to transfer \$2,000.00 from the Fund to Florida Sheriffs
8 Youth Ranches, Inc., and transfer \$30,000.00 to Downtown Vision
9 Alliance, Inc. for the Homeward Bound program. The appropriation
10 supports crime prevention and law enforcement expenditures and
11 activities. A Certification from the Jacksonville Sheriff's Office
12 that the subject appropriation from the Fund complies with Section
13 932.7055, *Florida Statutes*, is attached hereto as **Exhibit 2** and
14 incorporated herein by this reference.

15 **Section 3. Execution of Documents.** The Mayor, or her
16 designee, and the Corporation Secretary are hereby authorized to
17 execute and deliver any and all documents necessary to effectuate the
18 purpose set forth in Section 2 above.

19 **Section 4. Oversight.** The Jacksonville Sheriff's Office
20 shall oversee administration of the projects described herein.

21 **Section 5. Effective Date.** This Ordinance shall become
22 effective upon signature by the Mayor or upon becoming effective
23 without the Mayor's signature.
