WHEREAS, Jacksonville seeks to celebrate and elevate KHA's accomplishments and encourage residents to champion the growth, potential, and future of Jacksonville's youth; now therefore

BE IT RESOLVED by the Council of the City of Jacksonville:

Section 1. The City Council hereby establishes July 16, 2025, as "Jacksonville Children's Day" as a celebration of youth, family, and community investment and an opportunity to recognize the value and achievements of children in Jacksonville. The City Council extends appreciation to Kids Hope Alliance for their unwavering commitment to supporting children and youth across Duval County.
