

## DIAMOND FLOOR AMENDMENT

Council Member Diamond offers the following Floor Amendment to File No. 2025-138:

- (1) On **page 1, line 17**, after "CONTRACTS" insert "WITH THE EXCEPTION THAT SUCH PROHIBITION SHALL NOT APPLY TO AGREEMENTS FOR MEDICAL SERVICES PROVIDED BY SHANDS JACKSONVILLE MEDICAL CENTER, INC. ("SHANDS") OR TO PROGRAMS OR SERVICES FOR VICTIMS OF LABOR AND/OR SEX TRAFFICKING, OR FOR INDIVIDUALS ACTIVELY SERVING IN THE UNITED STATES MILITARY; AMENDING SECTION 118.106 (GRANTS FOR ECONOMIC DEVELOPMENT, CHILDREN AND YOUTH SERVICES CONTRACTS EXEMPT), PART 1 (GENERAL PROVISIONS), CHAPTER 118 (CITY GRANTS), *ORDINANCE CODE*, TO CREATE AN EXEMPTION FROM THE PROVISIONS OF CHAPTER 118, *ORDINANCE CODE*, FOR GRANTS TO THE STATE OF FLORIDA, DEPARTMENT OF HEALTH, DUVAL COUNTY HEALTH DEPARTMENT, THAT WOULD LIMIT THE PROVISION OF ANY PUBLIC HEALTH SERVICE BY SAID ENTITY TO ANY PERSON WHICH PROTECTS PEOPLE IN DUVAL COUNTY FROM THE SPREAD OF INFECTIOUS DISEASE(S)";
- (2) On **page 1, line 25 and page 2, line 1**, after "ALIENS" insert "WITH THE EXCEPTION THAT SUCH PROHIBITION SHALL NOT APPLY TO AGREEMENTS FOR MEDICAL SERVICES PROVIDED BY SHANDS OR TO PROGRAMS OR SERVICES FOR VICTIMS OF LABOR AND/OR SEX TRAFFICKING, OR FOR INDIVIDUALS ACTIVELY SERVING IN THE UNITED STATES MILITARY";
- (3) On **page 4, line 17**, after "Statutes" insert ", with the exception that such prohibition shall not apply to Provider Contracts for medical services provided by Shands Jacksonville Medical Center, Inc. or to Provider Contracts for programs or

services for victims of labor and/or sex trafficking, or for individuals actively serving in the United States military";

- (4) On **page 4, line 30**, after "Statutes" **insert** ", with the exception that such prohibition shall not apply to Small Provider Contracts for medical services provided by Shands Jacksonville Medical Center, Inc. or to Small Provider Contracts for programs or services for victims of labor and/or sex trafficking, or for individuals actively serving in the United States military";

- (5) On **page 5, line 15**, after "Statutes" **insert** ", with the exception that such prohibition shall not apply to Intra-Agency or other agreements for medical services provided by Shands Jacksonville Medical Center, Inc. or to Intra-Agency or other agreements for programs or services for victims of labor and/or sex trafficking, or for individuals actively serving in the United States military";

- (6) On **page 5, line 16½**, **insert** a new Section 3 to read as follows:

**"Section 3. Amending Section 118.106 (Grants for Economic Development, Children and Youth Services Contracts Exempt), Part 1 (General Provisions), Chapter 118 (City Grants), Ordinance Code.** Section 118.106 (Grants for Economic Development, Children and Youth Services Contracts Exempt), Part 1 (General Provisions), Chapter 118 (City Grants), Ordinance Code, is hereby amended to read as follows:

**CHAPTER 118 - CITY GRANTS**

**PART 1. - GENERAL PROVISIONS**

**\* \* \***

**Sec. 118.106. - Grant Contracts~~Grants~~ for Economic Development, Children and Youth Services, and Certain Public Health Services by the Duval County Health Department ~~Contracts-Exempt.~~**

Grant proposals that focus on economic development opportunities shall be processed through the Downtown Investment Authority (DIA) utilizing the application process established by the DIA and shall not be subject to this Chapter. Contracts and agreements managed by the Kids Hope Alliance under Chapter 77, Ordinance Code, shall not be subject to this Chapter. Grant funds provided to the State of Florida, Department of Health, Duval County Health Department, as authorized under Chapter 29, Ordinance Code, shall not be subject to any provision of this Chapter, including but not limited to Section 118.101 and subsection 118.201(f)(9), that would limit the provision of any public health service to any person which protects people in Duval County from the spread of infectious disease(s).";

- (7) Renumber the remaining Sections accordingly;
- (8) On **page 6, line 4 and page 7, line 9**, after "Statutes" **insert** ", with the exception that such prohibition shall not apply to agreements for medical services provided by Shands Jacksonville Medical Center, Inc. or to agreements for programs or services for victims of labor and/or sex trafficking, or for individuals actively serving in the United States military";
- (9) On **page 1, line 1**, amend the introductory sentence to add that the bill was amended as reflected herein.
