## **ORDINANCE 2019-698**

BE IT ORDAINED by the Council of the City of Jacksonville:

Section 1. Amending Section 500.112 (Redevelopment trust funds), Chapter 500, (Community Redevelopment - Policies and Procedures), Ordinance Code. Section 500.112 (Redevelopment trust funds), Chapter 500, (Community Redevelopment - Policies and Procedures), Ordinance Code, is hereby amended to read as follows:

Chapter 500 - COMMUNITY REDEVELOPMENT - POLICIES AND PROCEDURES

Sec. 500.112. - Redevelopment trust funds.

(d) Moneys in the redevelopment trust fund may be expended from time to time by an Agency for any purpose directly related to redevelopment in a Community Redevelopment Area pursuant to an approved community redevelopment plan only pursuant to an annual budget adopted by the Agency Board and only for the purposes specified in the annual budget of each CRA, including, but not limited to, the following:
