8 AN ORDINANCE CONCERNING THE JACKSONVILLE HOUSING  
9 AUTHORITY (JHA); CREATING A NEW SECTION 51A.113  
10 (ANNUAL PRESENTATION OF AFFORDABLE HOUSING  
11 PROGRAMS AND GOALS REQUIRED), PART 1  
12 (JACKSONVILLE HOUSING AUTHORITY ESTABLISHED),  
13 CHAPTER 51A (JACKSONVILLE HOUSING AUTHORITY),  
14 *ORDINANCE CODE*, TO PROVIDE THAT THE JHA SHALL  
15 MAKE AN ANNUAL PRESENTATION TO CERTAIN COUNCIL  
16 STANDING COMMITTEES; PROVIDING FOR CODIFICATION  
17 INSTRUCTIONS; PROVIDING AN EFFECTIVE DATE.

19 **BE IT ORDAINED** by the Council of the City of Jacksonville:

20 **Section 1. Creating a new Section 51A.113 (Annual**  
21 **presentation of affordable housing programs and goals required), Part**  
22 **1 (Jacksonville Housing Authority Established), Chapter 51A**  
23 **(Jacksonville Housing Authority), Ordinance Code.** A new Section  
24 51A.113 (Annual presentation of affordable housing programs and goals  
25 required), Part 1 (Jacksonville Housing Authority Established),  
26 Chapter 51A (Jacksonville Housing Authority), *Ordinance Code*, is  
27 hereby created to read as follows:

28 **CHAPTER 51A - JACKSONVILLE HOUSING AUTHORITY**

29 **PART 1. - JACKSONVILLE HOUSING AUTHORITY ESTABLISHED**

31 **Sec. 51A.113. - Annual presentation of affordable housing programs**

1 **and goals required.**

2 The Authority, through its Chief Executive Officer or designee, shall  
3 annually present in person and in writing to the Council committee  
4 of reference tasked with reviewing and making recommendations on  
5 measures addressing housing and the Council committee of reference  
6 tasked with reviewing and making recommendations on finance and budget  
7 matters a report regarding the Authority's affordable housing  
8 programs, its collaborative efforts with other entities focused on  
9 addressing housing issues, and its goals for the upcoming fiscal  
10 year. The chair of each Council committee shall provide notice to  
11 the Authority of the presentation date, which shall be in August of  
12 each year. The Authority shall file a copy of the written report  
13 with the Council Secretary on or prior to August 30<sup>th</sup> of each year.

14 **Section 2. Codification Instructions.** The Codifier and the  
15 Office of General Counsel are authorized to make all chapter and  
16 division "tables of contents" consistent with the changes set forth  
17 herein. Such editorial changes and any others necessary to make the  
18 *Ordinance Code* consistent with the intent of this legislation are  
19 approved and directed herein, and changes to the *Ordinance Code* shall  
20 be made forthwith and when inconsistencies are discovered.

21 **Section 3. Effective Date.** This Ordinance shall become  
22 effective upon signature by the Mayor or upon becoming effective  
23 without the Mayor's signature.
