7 OFFICE OF GRANT AND CONTRACT COMPLIANCE TO FUND
8 THE SALARY AND BENEFITS OF ONE FULL TIME
9 EMPLOYEE TO OVERSEE THE PUBLIC SERVICE GRANT'S
10 MICROGRANT PROGRAM; PROVIDING FOR CARRYOVER OF
11 FUNDS TO FISCAL YEAR 2022-2023; PROVIDING FOR
12 OVERSIGHT BY THE OFFICE OF GRANT AND CONTRACT
13 COMPLIANCE; PROVIDING AN EFFECTIVE DATE.

15 **BE IT ORDAINED** by the Council of the City of Jacksonville:

16 **Section 1. Appropriation.** For the 2021-2022 fiscal year,
17 within the City's budget, there is hereby appropriated the indicated
18 sum(s) from the account(s) listed in subsection (a) to the account(s)
19 listed in subsection (b):

27 The funding is an appropriation of \$100,000 from the City
28 Council Operating Contingency account to the Office of
29 Grant and Contract Compliance to fund the salary and
30 benefits of one full time employee to oversee the
31 microgrant program (\$90,000) and outreach (\$10,000).

1 **Section 2. Purpose.** The purpose of the appropriation in
2 Section 1 is to provide funding to the Office of Grant and Contract
3 Compliance to fund the salary and benefits of one full time employee
4 to oversee the PSG's microgrant program (\$90,000) and outreach
5 (\$10,000).

6 **Section 3. Carryover.** The funds appropriated in this
7 Ordinance shall not lapse but shall carryover to fiscal year 2022-
8 2023.

9 **Section 4. Oversight Department.** The Office of Grant and
10 Contract Compliance shall oversee administration of the program
11 referenced herein.

12 **Section 5. Effective Date.** This Ordinance shall become
13 effective upon signature by the Mayor or upon becoming effective
14 without the Mayor's signature.
