AN ORDINANCE APPROVING AND AUTHORIZING THE MAYOR, OR HER DESIGNEE, AND THE CORPORATION SECRETARY TO EXECUTE AND DELIVER, FOR AND ON BEHALF OF THE CITY OF JACKSONVILLE ("CITY"), AN AMENDMENT ONE TO ECONOMIC DEVELOPMENT AGREEMENT ("AGREEMENT") BETWEEN THE CITY AND ALLEGIS GROUP, INC. ("COMPANY"), TO AMEND THE DEFINITION OF THE PROJECT PARCEL THEREIN TO RECOGNIZE NEW OFFICE SPACE BEING UTILIZED BY THE COMPANY; AUTHORIZING APPROVAL OF TECHNICAL AMENDMENTS BY THE EXECUTIVE DIRECTOR OF THE OFFICE OF ECONOMIC DEVELOPMENT ("OED"); PROVIDING FOR OVERSIGHT BY THE OED; PROVIDING AN EFFECTIVE DATE.

WHEREAS, Allegis Group, Inc. (the "Company") and the City have previously entered into that certain Economic Development Agreement dated July 29, 2022 (the "Agreement"), pursuant to which the Company has committed to create 500 permanent full-time equivalent new jobs in Jacksonville with an average salary, exclusive of benefits, of \$53,000 per annum by December 31, 2026; and

WHEREAS, the Agreement is in full force and effect in accordance with its terms and the Company is in compliance therewith, however the Company has relocated a portion of its operations to different locations within the City, and the parties wish to amend the definition of the Project Parcel in the Agreement to reflect the same; now therefore,

BE IT ORDAINED by the Council of the City of Jacksonville:

Approved. The Mayor, or her designee, and the Corporation Secretary are hereby authorized to execute and deliver, for and on behalf of the City, the Amendment One to Economic Development Agreement ("Amendment One") substantially in the form placed attached hereto as Exhibit 1 and incorporated herein by this reference.

Amendment One may include such additions, deletions, and changes as may be reasonable, necessary, and incidental for carrying out the purposes thereof, as may be acceptable to the Mayor or her designee, with such inclusion and acceptance being evidenced by execution of the Amendment One by the Mayor or her designee. No modification of the Amendment One may increase the financial obligations or the liability of the City and any such modification shall be technical only and shall be subject to appropriate legal review and approval of the General Counsel or his or her designee and all other appropriate action required by law. "Technical" is herein defined as including, but not limited to, changes in legal descriptions and surveys, descriptions of infrastructure improvements and/or any road project, ingress and egress, easements and rights of way, performance schedules (provided that no performance schedule may be extended for more than one year without City Council approval), design standards, access and site plans which have no financial impact.

Section 2. Oversight Department. The Office of Economic Development shall oversee the Project described herein.

Section 3. Effective Date. This Ordinance shall become effective upon signature by the Mayor or upon becoming effective without the Mayor's signature.
