4 **ORDINANCE 2024-329**

5 AN ORDINANCE APPROVING AND AUTHORIZING THE  
6 MAYOR, OR HER DESIGNEE, AND THE CORPORATION  
7 SECRETARY TO EXECUTE AND DELIVER A MEMORANDUM OF  
8 UNDERSTANDING BETWEEN SOUTHERN OFF ROAD BICYCLE  
9 ASSOCIATION JACKSONVILLE CHAPTER, INC. AND THE  
10 CITY OF JACKSONVILLE FOR THE CONSTRUCTION, USE  
11 AND MAINTENANCE OF CITY MOUNTAIN BIKE SITES;  
12 FINDING THAT THESE CONTRACTUAL SERVICES ARE  
13 EXEMPT FROM COMPETITIVE SOLICITATION PURSUANT TO  
14 SECTION 126.107(G) (EXEMPTIONS), CHAPTER 126  
15 (PROCUREMENT CODE), *ORDINANCE CODE*; PROVIDING  
16 FOR OVERSIGHT BY THE PARKS, RECREATION AND  
17 COMMUNITY SERVICES DEPARTMENT; PROVIDING AN  
18 EFFECTIVE DATE.

20 **BE IT ORDAINED** by the Council of the City of Jacksonville:

21 **Section 1. Memorandum of Understanding Approved and**  
22 **Execution Authorized.** There is hereby approved, and the Mayor, or  
23 her designee, and the Corporation Secretary are hereby authorized to  
24 execute and deliver a Memorandum of Understanding between Southern  
25 Off Road Bicycle Association Jacksonville Chapter, Inc. ("SORBA") and  
26 the City of Jacksonville ("City"), in substantially the form placed  
27 **On File** with the Office of Legislative Services (the "MOU"). The MOU  
28 is for the construction, use and maintenance of existing and future  
29 mountain bike sites within the City at Tillie Fowler Regional Park,  
30 Bulls Bay Preserve, Kathryn Abbey Hanna Park, and other sites owned  
31 and approved by the City for mountain biking.

1           **Section 2.           Finding that Memorandum of Understanding is**  
2 **exempt from competitive solicitation under Section 126.107**  
3 **(Exemptions), Chapter 126 (Procurement Code), Ordinance Code.** Certain  
4 contractual and professional services are exempt from competitive  
5 solicitation pursuant to Section 126.107, *Ordinance Code*. In this  
6 case, the Council finds that the MOU falls under subsection (g) as  
7 contractual services to be provided by those prescribed in authorizing  
8 legislation. Accordingly, the MOU herein approved is not subject to  
9 competitive solicitation.

10           **Section 3.           Oversight Department.** The Parks, Recreation and  
11 Community Services Department shall oversee administration of the MOU  
12 described herein.

13           **Section 4.           Effective Date.** This Ordinance shall become  
14 effective upon signature by the Mayor or upon becoming effective  
15 without the Mayor's signature.
