**Justification for Waiver**

At the Jacksonville Environmental Protection Board (JEPB) hearing on March 15, 2021, board members determined that the use of the funds for this project was a worthwhile and beneficial use of trust fund monies and determined the necessity of an exception to ordinance code provisions was warranted. An exception to Section 126.107(g), Ordinance Code (supplies or services to be provided by those specifically prescribed within authorizing legislation that appropriates the same) is needed as Envirosuite will be named in the legislation. A waiver of Section 110.112 Ordinance Code is also needed as the initial payment is contemplated before the project completion. The proposal was favorably approved by unanimous decision of the Board.

**Justification for / Description of Transfer:**

To appropriate fund balance from the Environmental Protection Trust Fund to allow for an urban area odor study within Duval County.
