4 **RESOLUTION 2025-52**

5 A RESOLUTION CONFIRMING THE REAPPOINTMENT OF  
6 BOBBY STEIN, A DUVAL COUNTY RESIDENT AND ELECTOR  
7 OF THE CITY, AS A MEMBER OF THE GOVERNING BODY  
8 OF JEA, PURSUANT TO ARTICLE 21, *JACKSONVILLE*  
9 *CHARTER*, FOR A SECOND FULL TERM EXPIRING  
10 FEBRUARY 28, 2029; PROVIDING AN EFFECTIVE DATE.

11  
12 **WHEREAS**, on April 14, 2020, the City Council adopted Resolution  
13 2020-158-A confirming the Mayor's appointment of Bobby Stein to the  
14 governing body of JEA (the "JEA Board") for a partial term to expire  
15 February 28, 2021; and

16 **WHEREAS**, subsequently, Article 21 of the *Jacksonville Charter*  
17 was amended pursuant to Ordinance 2020-100-E which provided, in part,  
18 that four members of the JEA Board would be nominated for appointment  
19 by the Council President and confirmed by Council with the remaining  
20 three members to be appointed by the Mayor and confirmed by Council;  
21 and

22 **WHEREAS**, Ordinance 2020-100-E further revised Article 21 of  
23 the *Jacksonville Charter* to provide that one of the four JEA Board  
24 members nominated by the Council President be a former JEA employee,  
25 or person recommended by an employee, union or group of current or  
26 former JEA employees; and

27 **WHEREAS**, in 2021 the JEA unions recommended to the Council  
28 President that Bobby Stein be reappointed to the JEA Board for a  
29 first full term expiring February 28, 2025, and this nomination was  
30 approved by the City Council pursuant to Resolution 2021-36-A; and

31 **WHEREAS**, the JEA Supervisors Association has recommended to

1 the Council President that Bobby Stein be reappointed to the JEA  
2 Board for a second full term and a copy of the endorsement letter is  
3 attached hereto as **Exhibit 1**; now therefore

4 **BE IT RESOLVED** by the Council of the City of Jacksonville:

5 **Section 1. Confirmation of Reappointment.** The City Council  
6 hereby confirms the Council President's nomination of Bobby Stein, a  
7 Duval County resident and elector of the City, for reappointment as  
8 a member of the governing body of JEA, pursuant to Article 21,  
9 *Jacksonville Charter*, for a second full term expiring February 28,  
10 2029.

11 **Section 2. Effective Date.** This Resolution shall become  
12 effective upon signature by the Mayor or upon becoming effective  
13 without the Mayor's signature.
