4 **ORDINANCE 2024-783**

5 AN ORDINANCE APPROPRIATING \$10,000 FROM A
6 GENERAL FUND OPERATING - SUBSIDIES AND
7 CONTRIBUTIONS TO PRIVATE ORGANIZATIONS ACCOUNT
8 TO THE JACKSONVILLE SHERIFF'S OFFICE FOR THE
9 PROVISION OF TRAFFIC CONTROL SERVICES AT THE
10 INTERSECTION OF WELLS CREEK PARKWAY AND PHILIPS
11 HIGHWAY AS DESCRIBED HEREIN; PROVIDING FOR
12 CARRYOVER; PROVIDING FOR REVERTER OF FUNDS;
13 PROVIDING FOR OVERSIGHT BY THE JACKSONVILLE
14 SHERIFF'S OFFICE; REQUESTING EMERGENCY PASSAGE
15 UPON INTRODUCTION; PROVIDING AN EFFECTIVE DATE.

17 **BE IT ORDAINED** by the Council of the City of Jacksonville:

18 **Section 1. Appropriation.** For the 2023-2024 fiscal year,
19 within the City's budget, there is hereby appropriated the indicated
20 sum(s) from the account(s) listed in subsection (a) to the account(s)
21 listed in subsection (b):

28 (c) Explanation of Appropriation:

29 The funding above is an appropriation of \$10,000 from a
30 General Fund Operating - Subsidies and Contributions to
31 Private Organizations account to the Jacksonville

1 Sheriff's Office ("JSO") for the provision of traffic
2 control services at the intersection of Wells Creek Parkway
3 and Philips Highway.

4 **Section 2. Purpose.** The purpose of the appropriation in
5 Section 1 is to provide City funding for JSO officers to conduct
6 traffic control at the intersection of Wells Creek Parkway and Philips
7 Highway. These funds are in addition to funds previously appropriated
8 for off-duty traffic control services at this intersection by
9 Ordinance 2023-881-E. The funds will pay the costs for up to two (2)
10 police officers to provide these services four weekdays per week,
11 from 6:00 a.m. until 9:00 a.m., only on days when Duval County public
12 schools are in session. Traffic control services will only be provided
13 when JSO officers are available.

14 The funds appropriated herein shall be available for use only
15 after all funds appropriated pursuant to 2023-881-E to the Wells
16 Creek Property Owners Association, Inc. for traffic control services
17 at this intersection are exhausted. The funds appropriated herein
18 shall thereafter be applied to the cost for traffic control services
19 by JSO until exhausted or upon completion of the traffic signal
20 improvements at the subject intersection, whichever occurs first.

21 **Section 3. Carryover.** The funds appropriated herein shall
22 not lapse but shall carryover to fiscal year 2024-2025.

23 **Section 4. Reverter.** Any funds remaining after completion
24 of the project described herein shall be returned to the Special
25 Council Contingency within the General Operating Fund.

26 **Section 5. Oversight Department.** The Jacksonville
27 Sheriff's Office shall oversee the project described herein.

28 **Section 6. Requesting Emergency Passage Upon Introduction**
29 **Pursuant to Council Rule 4.901 Emergency.** Emergency passage upon
30 introduction of this legislation is requested. The nature of the
31 emergency is that the school year has commenced and there has been a

1 delay in installation of the anticipated traffic signal improvements
2 at the intersection of Wells Creek Parkway and Philips Highway.
3 Recognizing that traffic is at its heaviest in this area when school
4 is in session, which is also when traffic accidents are most likely
5 to occur, the City Council wants to ensure there is not a lapse in
6 the provision of off-duty traffic control services at this
7 intersection.

8 **Section 7. Effective Date.** This Ordinance shall become
9 effective upon signature by the Mayor or upon becoming effective
10 without the Mayor's signature.
